### **MINISTERIAL ORDER**

**WHEREAS** by Order and Declaration effective April 17, 2020, I declared that a state of emergency exists throughout the whole of the Province of Prince Edward Island as a result of the COVID-19 pandemic, which was renewed on April 30, 2020 and on May 31, 2020;

**AND WHEREAS** the Government of Canada has imposed restrictions on entry into Canada pursuant to section 58 of the *Quarantine Act* (Canada);

**AND WHEREAS** pursuant to section 11 of the Act, I am authorized to do everything necessary for the protection of property, the environment and the health or safety of persons within the Province;

**AND WHEREAS** pursuant to my authority described in section 11 of the Act, and after consultation with the Chief Public Health Officer, I have determined that it is necessary and advisable for the health, safety, and welfare of the people of Prince Edward Island, to make the following orders.

**THEREFORE** I hereby issue a renewed order as follows.

1. In this Order:

- (a) “essential services” means services that, if interrupted, would endanger the life, health, or personal safety of the whole or part of the population. A list of examples of essential services is published at:

<https://www.princeedwardisland.ca/en/topic/covid-19>.

- (b) “household” means the persons who normally reside with a seasonal resident;
- (c) “ordinarily present” means present in the province for six months or more, but includes transient persons who have not been resident in another province or country for six months or more if they have been resident in the province continuously for three months or more.
- (d) “peace officer” includes a police officer or any other person designated or appointed as a peace officer under any law of Prince Edward Island.
- (e) “resident” means a person who is legally entitled to be or to remain in Canada; makes his or her home in the Province; and is ordinarily present in the Province.
- (f) “seasonal resident” means a person who is a resident of a Canadian province or territory other than Prince Edward Island, but who owns, for seasonal use, residential property or a mobile home as defined in subsections 1(o) and 1(h)(i) the *Real Property Assessment Act*, RSPEI 1988, c R-4.

2. Every person arriving on Prince Edward Island at any and all points of entry, including by motor vehicle, airplane, helicopter, marine vessel, or otherwise, shall stop when instructed to do so by a peace officer, and answer any such questions and undergo such examinations as required by a peace officer, the Chief Public Health Officer, or any person assigned by the Chief Public Health Officer to conduct questioning and examinations.
3. All non-essential travel into Prince Edward Island is prohibited, and peace officers are hereby authorized to turn persons away when they attempt to enter the Province, and to require such persons to leave the Province immediately.
4. Non-essential travel includes but is not limited to the following:
  - (a) persons entering the Province to make or receive non-essential purchases, sales, and deliveries;
  - (b) persons entering the Province to visit, tour, sight-see, or for other social or recreational purposes; and
  - (c) such other classes of non-essential travel as the Chief Public Health Officer or her designate may direct.
5. Subject to section 6, the following persons may enter the Province:
  - (a) residents of Prince Edward Island;
  - (b) commercial vehicle drivers delivering goods (driving a commercial vehicle with a gross weight of over 4,500 kilograms);
  - (c) persons entering to provide essential services in the Province;
  - (d) persons permanently relocating to the Province to reside, or to work in essential services;
  - (e) persons entering for emergency medical purposes, including patients and persons necessary to travel with patients, and persons accompanying animals for emergency services at the Atlantic Veterinary College;
  - (f) persons exercising or facilitating custody and / or access with children;
  - (g) seasonal residents and members of their household who:
    - (i) do not have symptoms of COVID-19 or a diagnosis of COVID-19;
    - (ii) are not a close contact of someone with symptoms of COVID-19 or a diagnosis of COVID-19;
    - (iii) are not the subject of a federal, provincial or local public health order requiring them to remain in isolation;
    - (iv) have submitted and will comply with a self-isolation plan, upon entering the Province; and
    - (v) have been approved for entry in accordance with an entry schedule approved by the Chief Public Health Officer;

- 
- (h) persons entering for the purposes of transiting to / from the Magdalen Islands, Quebec;
  - (i) persons entering in exceptional circumstances or on compassionate grounds, as determined by the Chief Public Health Officer or her designate, subject to conditions that may be imposed by the Chief Public Health Officer or her designate.
6. Persons entering the Province under clauses 5(c) to (h) of this Order require a letter of approval issued in advance by a person designated by the Minister of Justice and Public Safety.
  7. Except as permitted under section 5 of this Order, persons arriving at the Province are prohibited from entering upon, and traveling into the Province from, any of the following areas:
    - (a) the highway at the entrance to the Confederation Bridge;
    - (b) the highway at the entrance to the Wood Islands ferry terminal;
    - (c) the highway at the entrance to the Souris ferry terminal;
    - (d) the highway or street at the entrance to the Charlottetown airport;
    - (e) any port, harbour, wharf, launching, beach, and any part of the shoreline of the Province; and
    - (f) any and all other points of entry to the Province.
  8. Where any person enters Prince Edward Island in contravention of this Order, a peace officer is hereby authorized and directed to return that person to an interprovincial border and require the person to leave the Province immediately, or at such a time as may be directed by a peace officer.
  9. Every person who enters the Province must comply with all orders and directions issued by the Chief Public Health Officer, including her order effective June 1, 2020.
  10. This Order is effective on June 1, 2020 at 12:00 a.m. and remains in effect until June 14, 2020 at 11:59 p.m., unless terminated sooner.

**EC2020-314**

**FAMILY LAW ACT**  
**ADMINISTRATIVE RECALCULATION OF**  
**CHILD SUPPORT REGULATIONS**  
**AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated May 19, 2020.)

Pursuant to subsection 61(5) of the *Family Law Act* R.S.P.E.I. 1988, Cap. F-2.1, Council made the following regulations after consultation with the Chief Justice of Prince Edward Island and the Chief Justice of the Trial Division:

**1. The *Family Law Act* Administrative Recalculation of Child Support Regulations (EC465/03) are amended by the addition of the following heading immediately preceding section 1:**

**INTERPRETATION**

**2. Section 4 of the regulations is amended by the addition of the following after subsection (5):**

(6) A notice sent by regular mail in accordance with subsection (5) is deemed to be received by a party upon the expiration of seven days after the notice is mailed to the party. Deemed receipt

**3. (1) Subsection 6(2) of the regulations is amended by the deletion of the words “registered mail” and the substitution of the words “regular mail”.**

**(2) Section 6 of the regulations is amended by the addition of the following after subsection (2):**

(3) A notice sent by regular mail in accordance with this section is deemed to be received by a party upon the expiration of seven days after the notice is mailed to the party. Deemed receipt

**4. (1) Clause 8(3)(b) of the regulations is amended by the addition of the word “of” after the words “a copy”.**

**(2) Section 8 of the regulations is amended by the addition of the following after subsection (3):**

Deemed receipt (4) An order sent by regular mail in accordance with subsection (3) is deemed to be received by a party upon the expiration of seven days after the order is mailed to the party.

**5. (1) Subsection 12(2) of the regulations is amended by the deletion of the words “registered mail” and the substitution of the words “regular mail”.**

**(2) Section 12 of the regulations is amended by the addition of the following after subsection (2):**

Deemed receipt (3) A notice sent by regular mail in accordance with this section is deemed to be received by a party upon the expiration of seven days after the notice is mailed to the party.

**6. Section 14 of the regulations is amended by the addition of the following after subsection (3):**

Deemed receipt (4) An order sent by regular mail in accordance with subsection (3) is deemed to be received by a party upon the expiration of seven days after the order is mailed to the party.

**7. The regulations are amended by the addition of the following after section 15:**

#### EXTENSION OF TIME PERIODS

Definition **16. (1)** In this section, “state of public health emergency” means the state of public health emergency declared pursuant to subsection 49(1) of the *Public Health Act* R.S.P.E.I. 1988, Cap. P-30.1, by Order No. EC2020-174.

Suspension of time period (2) Notwithstanding sections 5 to 8 and 10 to 14, a requirement for a party or the Recalculation Officer to do or obtain anything within a specified time period is, subject to an order of the court, suspended for the period commencing on the date on which this section comes into force and ending on the date that is 30 days after the date on which the state of public health emergency ends.

When time begins to run (3) Where a time period within which a party or the Recalculation Officer is required to do or obtain anything under sections 5 to 8 or 10 to 14 is temporarily suspended under subsection (2),  
 (a) the days during which the suspension is in effect shall not be counted; and  
 (b) the time period resumes running on the date that the temporary suspension ends in accordance with subsection (2).

Revocation (4) This section is revoked 90 days after the date on which Order No. EC202-174, the declaration of a state of public health emergency pursuant to subsection 49(1) of the *Public Health Act*, is terminated or expires without being continued under that Act.

---

**8. These regulations come into force on May 30, 2020.****EXPLANATORY NOTES**

**SECTION 1** amends the *Family Law Act* Administrative Recalculation of Child Support Regulations to add the heading “INTERPRETATION” immediately preceding section 1.

**SECTION 2** amends section 4 of the regulations to add a new subsection 4(6) that establishes when a notice sent by regular mail under that section is deemed to have been received by a party.

**SECTION 3** amends subsection 6(2) of the regulations to change a reference to “registered mail” to “regular mail”. The section also adds a new subsection 6(3) that establishes when a notice sent by regular mail under that section is deemed to have been received by a party.

**SECTION 4** amends clause 8(3)(b) of the regulations to correct a typographical error, and also add a new subsection 8(4) that establishes when an order sent by regular mail under that section is deemed to have been received by a party.

**SECTION 5** amends subsection 12(2) of the regulations to change a reference to “registered mail” to “regular mail”. The section also adds a new subsection 12(3) that establishes when a notice sent by regular mail under that section is deemed to have been received by a party.

**SECTION 6** amends section 14 of the regulations to add a new subsection 14(4) that establishes when an order sent by regular mail under that section is deemed to have been received by a party.

**SECTION 7** amends the regulations by adding a new section 16 that suspends the time periods during which a party or the Recalculation Officer must do specified things during a state of public health emergency, as defined, and for 30 days following. The days during which the suspension is in effect are not counted, and time resumes running on the date the temporary suspension ends. The section is revoked 90 days after the date on which Order No. EC2020-174, the declaration of a state of public health emergency pursuant to the *Public Health Act*, is terminated or expires without being continued under that Act.

**SECTION 8** provides for the commencement of these regulations.

**REGULATED HEALTH PROFESSIONS ACT  
OCCUPATIONAL THERAPISTS REGULATIONS  
AMENDMENT**

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

**1. Section 1 of the *Regulated Health Professions Act Occupational Therapists Regulations* (EC34/18) is amended**

**(a) in clause (b), by the addition of the words “Prince Edward Island” before “College of Occupational Therapists”; and**

**(b) in clause (d),**

**(i) in subclause (iv), by the deletion of the words “while undertaking roles involving education, consultation, management, research and other areas of practice”,**

**(ii) in subclause (v), by the deletion of the semicolon and the substitution of a comma, and**

**(iii) by the addition of the following after subclause (v):**

(vi) engaging in research, education, management or administrative activities incidental to performing the services referred to in subclauses (i) to (v);

**2. Section 3 of the regulations is revoked and the following substituted:**

Continuation of  
College under new  
name

**3. The College of Occupational Therapists, which was continued under these regulations on February 1, 2018, is continued as the college for occupational therapy under the name Prince Edward Island College of Occupational Therapists.**

**3. These regulations come into force on May 30, 2020.**

**EXPLANATORY NOTES**

**SECTION 1** updates the name of the college in the definition of “Council” and revokes a portion of a provision and adds a provision in the definition of “occupational therapy”.

**SECTION 2** continues the college under the new name Prince Edward Island College of Occupational Therapists.



**SECTION 3** provides for the commencement of these regulations.
