EC2019-400

ROADS ACT
HIGHWAY ACCESS REGULATIONS
AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated June 4, 2019.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. Schedule C-1, LOCAL (CLASS 1) HIGHWAYS, to the *Roads Act Highway Access Regulations (EC580/95)* is amended by the revocation of subsection 1(315).

2. Schedule C-2, LOCAL (CLASS 2) HIGHWAYS to the regulations is amended by the addition of the following after subsection 1(318):

(318.1) **Thompson Point Road RI41292:** The paved portion of the Thompson Road commencing at the intersection of Route 104 in the settlement of Margate to the end of the pavement.

3. Schedule D, SEASONAL HIGHWAYS to the regulations is amended by the addition of the following after subsection 1(539):

(539.1) **Thompson Point Road RI41292:** The unpaved portion of the Thompson Road commencing at the intersection of Route 104 in the settlement of Margate to the end of the road.

4. These regulations come into force on June 15, 2019.

EXPLANATORY NOTES

SECTION 1 revokes the Roy Thompson Road RI41292 from Schedule C-1, LOCAL (CLASS 1) HIGHWAYS. This road should be classified as a Local (Class 2) highway as it does not connect to any other provincial highway. It no longer is named the Roy Thompson Road but instead is named Thompson Point Road and as well the current definition has it beginning at Route 6 which is no longer the case as it now begins at Route 104 as a result of intersection improvements that were undertaken over ten years ago.

SECTION 2 inserts RI41292 into Schedule C-2, LOCAL (CLASS 2) HIGHWAYS as it was removed from Schedule C-1, LOCAL (CLASS 1) HIGHWAYS. RI41292 is also renamed to the Thompson Point Road as it is known locally and as well it is redefined as now beginning at Route 104 instead of Route 6 as a result of intersection improvements that were undertaken over ten years ago.

SECTION 3 adds the currently unclassified unpaved portion of RI41292, Thompson Point Road, beginning at Route 104 in Margate, to Schedule D Seasonal Highways.

SECTION 4 provides for the commencement of these regulations.
