(k.3) "Seed Dealer License" means a license issued pursuant to section 3.1;

Fees 4.1 (1) Section 4 shall not apply to Seed Dealer Licenses.

(2) The license fee payable to the Board for a Seed Dealer License shall be \$400 plus applicable taxes annually, and such license shall be issued to a Seed Producer only on the Seed Producer agreeing to the terms and conditions as set forth in the application for the license.

Penalties 16.1 The following sections of this Board Order PB09-1 shall not apply to holders of a Seed Dealer License: subsection 7(4) and section 12.

4. The following is added as sub-section 13(3) of Board Order PB09-1:

Details of sale to be furnished to Board 13(3) Each Seed Producer shall provide to the Board the Seed Producer's Canadian Food Inspection Agency seed certificate records (including application and growing crop certificate) prior to any shipment of Seed Potatoes, and shall also provide to the Board, when requesting a transportation number for any shipment, the certification number for the Seed Potatoes comprising such shipment.
