(1) The Articling and Admissions Committee may organize and conduct a P.E.I. bar admission course for articulated clerks, which shall include such programs as may be prescribed by the Council upon the recommendation and advice of the Articling and Admissions Committee from time to time. This course may be organized and held in conjunction with ~~the bar admission course of Nova Scotia~~ a bar admission course of a common law province of Canada.
15. (1) The term of service of an articulated clerk shall be computed from a date fixed by the Council.

#### PART 2 - INSPECTIONS

2. The Minister may appoint a person who holds an appointment as an environment officer under the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9, as an inspector for the purposes of the Act and these regulations. Appointment of inspectors
3. (1) An inspector may enter any land, premises or business at any reasonable time for the purpose of carrying out the inspector’s duties under the Act and these regulations. Inspectors, powers to enter and search
- (2) For the purpose of carrying out the duties referred to in subsection (1), an inspector may Inspection
- (a) require the production of invoices or supplier information for checkout bags or reusable bags from a retailer; and
- (b) inspect and take samples of a checkout bag or reusable bag being distributed by a retailer.
- (3) No person shall neglect or refuse to produce an invoice or supplier information as required by an inspector under subsection (2). Requirement to comply with request of inspector
- (4) No person shall furnish an inspector with false information or neglect or refuse to furnish information required by an inspector in the exercise of the inspector’s duties under the Act and these regulations. Prohibition - false information
- (5) No person shall obstruct an inspector in the exercise of the inspector’s duties under the Act and these regulations. Obstruction of inspector

Assist inspector in carrying out duties (6) Every person shall, to the best of the person's abilities, assist an inspector in carrying out the inspector's duties under the Act and these regulations, including but not limited to facilitating any entry, inspection, examination or inquiry considered necessary by the inspector.

Protection from personal liability (7) The Minister and an inspector are not personally liable for any loss or damage suffered by any person by reason of anything done or omitted to be done in good faith in the purported exercise of any powers or performance of any duties under the Act or these regulations.

### PART 3 - CHECKOUT BAGS

Unsuitable bags 4. For greater certainty, for the purposes of clause 5(3)(b) of the Act, a business is not required to accept the return of a bag already used by a customer for use as a checkout bag if the bag

- (a) is not empty;
- (b) is unsanitary;
- (c) is damaged; or
- (d) is otherwise in a condition that makes it unsuitable for use as a checkout bag.

Commencement 5. These regulations come into force on July 27, 2019.

### EXPLANATORY NOTES

**SECTION 1** establishes definitions for the purposes of the regulations.

**SECTION 2** provides for the Minister to appoint environment officers under the *Environmental Protection Act* as inspectors for the purposes of the Act and regulations.

**SECTION 3** establishes the powers and duties of an inspector for the purposes of the Act and regulations, requires persons to comply with the request of an inspector to produce invoices or supplier information, prohibits the giving of false information to an inspector or obstructing an inspector and requires persons to assist an inspector in carrying out the inspector's duties. The section also provides that the Minister and an inspector are not personally liable for loss or damage suffered by any person by reason of anything done or omitted to be done in good faith in the purported exercise of any powers or performance of any duties by either of them.

**SECTION 4** clarifies the application of clause 5(3)(b) of the Act to used bags that may be returned to a business for use as a checkout bag.

**SECTION 5** provides for the commencement of the regulations.
