Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following order:

**RAW MILK STANDARDS ORDER**

- Application      1. This order establishes the quality standards for production of milk on dairy farms in Prince Edward Island.
- Definitions      2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations under the Act, unless differentiated herein and as hereinafter defined:
- (1) “bulk milk grader” means a person licensed by to inspect, grade and receive milk, as described in DFPEI orders, and who holds a bulk milk grader’s licence;
  - (2) “bulk milk grader’s licence” means a licence issued by DFPEI for the performance of duties as a bulk milk grader described in DFPEI orders;
  - (3) “dairy animal” means a cow of the bovine family kept for the purposes of milking;
  - (4) “bulk milk tank” means a vessel for cooling and holding milk until it can be transferred to a transport vehicle;
  - (5) “dairy farm” means a farm where dairy animals are kept for milking and from which milk is marketed or sold for processing in a dairy plant or for human consumption, and includes all buildings, yards and premises occupied or used in connection with the production of milk;
  - (6) “DFPEI” means Dairy Farmers of Prince Edward Island;
  - (7) “inhibitor” means any substance, other than a bacterial culture, that does not occur naturally in milk and inhibits the growth of bacteria in milk or negatively affects the organoleptic properties of milk or dairy products;
  - (8) “milk” means a normal lacteal secretion obtained from the mammary gland of a dairy animal that is free of colostrum, and includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;
  - (9) “producer” means a person who holds quota and has no other interest in any other quota, who markets or sells milk that has been produced by a herd of dairy animals owned or controlled by the producer;
  - (10) “prohibited milk” is milk as described in s.5 of this order;
  - (11) “raw milk” means milk that has not been heated beyond 40°C or undergone any treatment that has an equivalent effect;

- (12) “sale” means the act of selling milk and includes trade or barter;
- (13) “sample” means a representative part of the raw milk offered for sale that is presented for inspection, grading or for testing;
- (14) “standard” is a rule for the measure of quality or operations as established by DFPEI; and
- (15) “transport vehicle” means a vehicle used for the transport of milk and includes a bulk milk truck.
- Determining milk quality 3. All raw milk produced in PEI shall be subject to sampling, inspection, grading and testing to ensure it meets the standards established in this order. The DFPEI Raw Milk Sampling, Inspection, Grading and Testing Order establishes the procedures applied to these processes.
- Raw milk standards 4. All milk sold or offered for sale in PEI shall meet the standards specified in this order. If milk is sold or offered for sale that does not meet these standards it shall be subject to penalties and restrictions as established in the DFPEI Violations and Penalties Order.
- Prohibited milk 5. Milk shall be deemed as prohibited milk that shall not be offered for sale and DFPEI shall not purchase milk that:
- (1) comes from an animal 15 days prior to or 3 days after parturition, or such longer period as is required to ensure the milk is free of colostrum;
  - (2) contains any inhibitor, chemical, toxin, drug or other foreign substance; and
  - (3) comes from any dairy farm where standards for care of the animals on that farm are not met, as determined by:
    - a. an animal protection officer appointed by The Minister of Agriculture and Land who has found that the animals kept on those premises are in distress, as defined in the *Animal Welfare Act* and regulations thereunder; or
    - b. an inspector or other appointed representative of DFPEI has found that standards of care in the current Code of Practice or any other standard of care related to cattle on the farm are not met, such that animals are judged to be in distress.
- Inspection and grading 6. A bulk milk grader shall sample, inspect and grade the milk offered for sale and shall accept or reject the milk contained in the bulk milk tank for purchase based on its flavour, appearance, odour, temperature or other abnormalities, as specified in this order.
- Unacceptable milk 7. Milk shall be rejected and the bulk milk grader shall leave the milk in the bulk milk tank if the milk:
- (1) is prohibited milk;
  - (2) cannot be sampled;
  - (3) is not stored at the temperature specified in this order;

- 
- 
- (4) is abnormal in odour;
- (5) is abnormal in flavour;
- (6) has odours or flavours that adversely affect its organoleptic qualities;
- (7) contains blood or any other foreign particles; or
- (8) is watery or coagulated.
- Temperature 8. The temperature of milk stored in a bulk milk tank shall be greater than 0 degrees Celsius and less than or equal to 4 degrees Celsius, except as permitted when milk is cooling during and immediately following milking.
- Quality Testing 9. Milk purchased for processing shall be tested and assessed against the standards established in s.10, s.11 and s.12 of this order.
- Added Water 10. (1) The approved method for identifying the addition of water to milk is analysis of the freezing point of the milk.
- (2) The freezing point of milk shall not exceed -0.525 degrees Celsius (equal to -0.507 degrees Celsius).
- Bacteria 11. The individual bacteria count (IBC) in milk shall not exceed 121,000 bacteria per ml.
- Somatic cells 12. The somatic cell count (SCC) in milk shall not exceed 400,000 cells per ml.
- Revocation 13. DFPEI Order 2017-09 is hereby revoked.
- Commencement 14. This order shall come into force on the 1st day of August 2023.

- (12) “laboratory” means the Prince Edward Island Analytical Laboratory or an alternate that has been recognized to be in compliance with an international standard (ISO/IEC 17025) that is designated by DFPEI to analyse raw milk samples;
- (13) “milk” means a normal lacteal secretion obtained from the mammary gland of a dairy animal that is free of colostrum, and includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;
- (14) “milk components” means the three constituent parts of milk that are measurable and used to determine the value of milk, namely butterfat, protein and other solids;
- (15) “official sample” means a milk sample as described in s.7 of this order;
- (16) “processor” means a person performing any processing of milk and may operate one or more dairy plants;
- (17) “producer” means a person or partnership that holds quota and has no other interest in any other quota, who markets or sells milk that has been produced by a herd of dairy animals owned or controlled by the producer;
- (18) “raw milk” means milk that has not been heated beyond 40°C or undergone any treatment that has an equivalent effect;
- (19) “sale” means the act of selling milk and includes trade or barter;
- (20) “sample” means a representative part of the raw milk offered for sale that is presented for inspection, grading or for testing;
- (21) “test week” means a period of seven consecutive days extending from a Saturday to the following Friday; and
- (22) “transport vehicle” means a vehicle used for the transport of milk and includes a bulk milk truck.

Approved  
testing methods

3. Only approved and validated methods which conform to the handling, procedural, and quality control parameters described in the most recently published “Standard Methods for the Examination of Dairy Products” approved by the American Public Health Association, the “Official Methods of Analysis of the Association of Official Analytical Chemists”, any method recognized by the International Dairy Federation/International Standards Organization (ISO), or any other method approved by the Board shall be used for testing milk.

Approved  
laboratory

4. Raw milk samples obtained for the purposes specified in this order shall only be tested by the Prince Edward Island Analytical Laboratory, or an alternative accredited laboratory, using the approved methods described in s.3.

Inhibitor  
testing products

5. Screening and confirmatory tests for inhibitors shall be performed using an approved inhibitor testing product:
  - (1) the choice of testing product shall be approved by the laboratory, processors and DFPEI;
  - (2) all inhibitor screening tests shall be performed using the same inhibitor testing product as the laboratory; and

	(3) any test performed using other testing products that cannot be verified using the approved testing product shall not be accepted by DFPEI and any resulting costs or liability shall be for the account of the processor using the unapproved test.
Requirement to sample	6. Raw milk samples shall be drawn from the milk present in the bulk tank on each farm every time milk is offered for sale. Samples shall be used by the bulk milk grader to inspect and grade the milk, prior to loading it on the transport vehicle, to determine if it is acceptable for sale. Samples from each farm shall also be used as required by the laboratory for testing the milk to determine: <ol style="list-style-type: none"> <li>(1) if the milk contains inhibitors;</li> <li>(2) if the milk complies with quality standards established in the current DFPEI Raw Milk Standards Order; and</li> <li>(3) the milk component content, which is used for calculating the value of the milk.</li> </ol>
Official samples	7. Only samples drawn by a bulk milk grader or dairy inspector and held in the continuous custody of a bulk milk grader or dairy inspector until inspected, graded or shipped to the laboratory shall be considered valid official samples. After a sample is drawn, no person shall be granted access to the sample who is not part of the inspection, grading, shipping or testing process. Only official samples may be used for testing as specified in this order.
Volume of samples	8. Samples are normally drawn in volumes less than one hundred (100) millilitres; but shall be drawn in sufficient volume to meet inspection, grading and testing requirements as specified in this order at the time the milk is offered for sale.
Number of samples required	9. A bulk milk grader shall draw: <ol style="list-style-type: none"> <li>(1) at least one sample to inspect and grade the milk on each farm before it is removed from the producer's bulk milk tank—these samples may be disposed on site if appropriate;</li> <li>(2) one or more samples to be retained as official samples in custody as specified in s.7 of this order; and</li> <li>(3) one or more samples for extraordinary testing, such as CFIA testing or research testing, as directed by DFPEI.</li> </ol>
No compensation for samples	10. The volume of milk drawn for samples is considered insignificant compared to the volume of milk offered for sale by dairy farms and is required in the normal course of marketing milk. Therefore, no compensation shall be paid for any volume of milk drawn as samples prior to measurement of the volume of milk available for sale.
Drawing samples	11. Each official sample shall be drawn: <ol style="list-style-type: none"> <li>(1) following agitation of the milk contained in the tank for at least 5 minutes or as otherwise directed by DFPEI to assure uniformity of the milk;</li> <li>(2) in an aseptic manner; and</li> <li>(3) by means of:</li> </ol>



- 
- 
- (a) a mechanical sampler on the bulk milk truck;
- (b) a direct extraction from the producer's bulk milk tank using a sanitized pipette;
- (c) a direct extraction from the producer's bulk milk tank using a sanitized dipper that has been rinsed in the milk prior to sampling; or
- (d) any other sanitary sampling method approved by DFPEI.
- Inspection  
and grading
12. A bulk milk grader shall inspect and grade the milk offered for sale and shall accept the milk for purchase or reject the milk contained in the bulk milk tank on the basis of its flavour, appearance, odour, temperature or other abnormalities, as specified in the DFPEI Raw Milk Standards Order.
- Milk testing  
frequency
13. The laboratory shall select samples from the official samples collected at the time of raw milk pick up from each producer for testing. The frequency of testing for each requirement or standard shall be as follows:
- (1) at least one sample each test week for freezing point;
- (2) at least one sample each test week for bacteria;
- (3) all samples for milk component content;
- (4) all samples for somatic cell count;
- (5) as provided for in s.14 and s.15 of this order for inhibitors; and
- (6) as may be otherwise directed by DFPEI.
- Inhibitor  
screening test  
procedures
14. (1) Every dairy plant receiving milk shall ensure that a screening test is performed to detect the presence of inhibitors in any milk offered for sale. All bulk loads of milk shall be tested for inhibitors by:
- (a) the receiving dairy plant before the milk is unloaded; or
- (b) an external milk tester, contracted by the processor purchasing the milk and approved by the Board, after the milk has been unloaded at the receiving plant.
- (2) In the case where a transport vehicle has multiple compartments, all compartments shall be tested.
- (3) Any additional costs or losses created by accepting the milk before it has been tested by an external milk tester as described in s.14.(1)(b) of this order shall be the responsibility of the processor purchasing the milk.
- Dairy plant  
confirmation  
tests
15. When a screening test detects the possible presence of one or more inhibitors in a compartment, the following actions shall be undertaken to verify the screening test results:
- (1) the dairy plant shall conduct two additional inhibitor tests on milk samples from the suspected contaminated compartment and simultaneously test two control samples, one that is known to be inhibitor free and one that is known to contain the inhibitor;

- 
- (2) if the control sample results verify the tests are functioning correctly and neither of the additional tests indicate the presence of an inhibitor, the original screening result shall be considered an error and the milk shall be accepted for processing; and
- (3) If the control sample results verify the tests are functioning correctly and at least one of the additional tests indicate the presence of one or more inhibitors, the dairy plant shall:
- (a) reject all the milk contained in the contaminated compartment;
  - (b) notify a DFPEI inspector of the contamination; and
  - (c) forward the remainder of the sample from the contaminated compartment and the samples collected from each farm bulk tank that was loaded into the contaminated compartment to the laboratory for further testing.
- Laboratory inhibitor tests 16. If dairy plant confirmation tests indicate that one or more inhibitors are present in a bulk tank sample, the laboratory shall:
- (1) conduct two inhibitor tests on the milk from the load sample, and also simultaneously test two control samples, one that is known to be inhibitor free and one that is known to contain the inhibitor;
  - (2) test all the producer samples from the contaminated compartment;
  - (3) determine which producers were responsible for contamination of the compartment; and
  - (4) communicate the findings to a DFPEI inspector and the dairy plant.
- DFPEI inhibitor response 17. Upon receipt of confirmation of the presence of inhibitors from the laboratory, DFPEI shall:
- (1) confirm the dairy plant's decision to discard all milk from the contaminated compartment; and
  - (2) notify the producer responsible for the contamination and perform actions indicated in the DFPEI Violations and Penalties Order.
- Test for added water 18. (1) The test to determine the presence of added water is analysis of the freezing point of the milk samples.
- (2) All samples shall be screened using an electronic milk analysis device and once per week the results of the freezing point screening for each producer shall be selected to be an official sample for freezing point testing.
  - (3) Any official sample that is identified as possibly exceeding the freezing point standard shall be retested by cryoscopy to accurately determine its freezing point.
  - (4) The freezing point of the milk shall be reported and recorded in degrees Hortvet or degrees Celsius.
- Test for bacteria 19. (1) Each week one official sample of milk from each producer shall be selected for bacteria testing.

- 
- (3) Bacteria testing shall be performed using an electronic milk bacteria analysis device.
- (4) The test shall determine an individual bacteria count of the number of bacteria present in a ml of milk.
- (5) Bacteria test results shall be reported and recorded as individual bacteria counts (IBC).
- Test for somatic cells 20. (1) All official samples of milk from each producer shall be selected for somatic cell testing.
- (2) Somatic cell testing shall be performed using an electronic milk analysis device
- (3) The test shall determine the number of somatic cells present in a ml of milk.
- (4) Somatic Cell Test Results shall be reported and recorded as somatic cell counts (SCC).
- Test for milk components 21. (1) All official samples of milk from each producer shall be tested to determine the component content in that producer's milk.
- (2) Milk component testing shall be performed using an electronic milk analysis device.
- (3) The milk analysis device expresses the content of each component in a mass over mass (grams of component per Kg of milk) data format.
- (4) DFPEI shall receive the mass over mass data, then convert that data to the industry recognized mass over volume (Kg/hL) format using a standard calculation and factors provided by the Canadian Laboratory Service or another recognized authority competent to provide the information.
- (5) The component content shall be reported to producers and industry partners in the mass over volume format, which shall be used to determine the value of the milk for invoicing processors and for paying producers.
- Reporting test results 22. All test results shall be reported to DFPEI by the laboratory. DFPEI shall distribute test results to producers using electronic and other means and shall use the test results to determine compliance with milk quality standards and to establish the milk component content for the purpose of invoicing processor and paying producers.
- Revocation 23. DFPEI order 2017-08 is hereby revoked.
- Commencement This order shall come into force on the 1st day of August 2023.

**Order: 2023-05**  
**Effective: 1 August 2023**

Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

**VIOLATIONS AND PENALTIES ORDER**

- Application 1. This order establishes the criteria for determining violations of the standards and rules established in orders made by Dairy Farmers of Prince Edward Island; or laws of the Government of Prince Edward Island and the Government of Canada; and the penalties that shall be applied in the event such violations occur.
- Definitions 2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations under the Act, unless differentiated herein and as hereinafter defined:
- (1) “AWA” means the *Animal Welfare Act* R.S.P.E.I. 1988, Cap. A-11.2;
  - (2) “bulk milk tank” means a vessel for cooling and holding milk until it can be transferred to a transport vehicle;
  - (3) “Code of Practice” means the Code of Practice for the Care and Handling of Dairy Cattle and specifically the version currently adopted by DFPEI;
  - (4) “dairy animal” means a cow of the bovine family kept for the purposes of milking;
  - (5) “dairy farm” means a farm where dairy animals are kept for milking and from which milk is marketed or sold for processing in a dairy plant or for human consumption, and includes all buildings, yards and premises occupied or used in connection with the production of milk;
  - (6) “DFPEI” means Dairy Farmers of Prince Edward Island;
  - (7) “distress” means, in respect of an animal,
    - (i) any pain, suffering, harm, extreme anxiety or other impairment of health or well-being,
    - (ii) any lack of care or treatment specified in the Code of Conduct;
    - (iii) any occurrence of an activity prohibited under section 4, 5 or 6 of the AWA;
    - (iv) “farm inspection” is the official viewing or examination of the dairy farm premises and operations, conducted by an inspector appointed by DFPEI, which is used to ensure that milk production is conducted in accordance with all DFPEI Orders or other applicable regulations;
    - (v) “infraction” means a breach or infringement of any standard or rule established by DFPEI;

- (vi) “inhibitor” means any substance, other than a bacterial culture, that does not occur naturally in milk and inhibits the growth of bacteria in milk or negatively affects the organoleptic properties of milk or dairy products;
- (vii) “inspector” means a person who is a bulk milk grader and is appointed by the Board to inspect dairy farms, dairy barns, milking parlours, milking areas, milk houses, milk handling equipment and transport vehicles as described in this order and other orders of the Board, to ensure compliance with this order and other orders of the Board regulating the production, handling, storage, transportation and marketing of milk;
- (viii) “milk” means a normal lacteal secretion obtained from the mammary gland of a dairy animal that is free of colostrum, and includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;
- (ix) “proAction®” means a trademarked program developed by dairy farmers to ensure milk production meets societal expectations for animal welfare, biosecurity, environmental sustainability, food safety, livestock traceability and milk quality that has been adopted by all provinces;
- (x) “producer” means a person who holds quota and has no other interest in any other quota, who markets or sells milk that has been produced by a herd of dairy animals owned or controlled by the producer;
- (xi) “raw milk” means milk that has not been heated beyond 40°C or undergone any treatment that has an equivalent effect;
- (xii) “sale” means the act of selling milk and includes trade or barter;
- (xiii) “sample” means a representative part of the raw milk offered for sale that is presented for inspection, grading or for testing;
- (xiv) “standard” means a rule for the measure of quality or operations as established by DFPEI;
- (xv) “validation” is the process of evaluation to ensure compliance with proAction® program standards. It may be accomplished through an independent evaluation of on farm program records or through a self-declaration, as directed by the Board; and
- (xvi) “violation” means a failure to meet standards by the accumulation of one or more infractions as determined by this Order.

Production  
standards

3. All raw milk sold or offered for sale in PEI shall meet the standards specified in the DFPEI Raw Milk Standards Order.

Operating  
Conditions

4. Milk shall be produced in conditions that meet the standards for dairy farms established in other DFPEI orders, and other laws and regulations of the Government of Prince Edward Island and the Government of Canada.

Prohibited milk

5. Milk shall be deemed as prohibited and not be offered for sale and DFPEI shall not purchase milk that:

- (1) comes from an animal 15 days prior to or 3 days after parturition, or such longer period as is required to ensure the milk is free of colostrum;
- (2) contains any inhibitor, chemical, toxin, drug or other foreign substance;
- (3) comes from any dairy farm where standards for care of the animals on that farm are not met, as determined by:
  - a. an animal protection officer appointed by The Minister of Agriculture and Land who has found that the animals kept on those premises are in distress, as defined in the AWA and regulations thereunder; or
  - b. an inspector or other appointed representative of DFPEI has found that standards of care in the current Code of Practice or any other standard of care related to cattle on the farm are not met, such that animals are judged to be in distress.

Application of  
Prohibition

6. In any instance where a dairy farm's production is deemed to be prohibited milk, DFPEI shall immediately prohibit milk sales from that farm and place the milk on the farm under detention by placing a notice on the bulk milk tank and directing transporters to cease pick up of milk from that farm until requirements for reinstatement are met.

Infractions

7. An infraction shall be deemed to have occurred in any single instance where a raw milk production standard or operating condition has not been met, as determined by farm inspection, validation, milk inspection, milk grading, or milk testing required in DFPEI Orders. Violations shall be recorded as indicated in this section for any of the following violations:

- (1) for added water, when testing indicates a freezing point greater than that allowed in the DFPEI Raw Milk Standards Order;
- (2) for bacteria when, when testing indicates a bacteria count greater than that allowed in the DFPEI Raw Milk Standards Order;
- (3) for proAction®, when a producer fails a validation or is otherwise deemed to be in violation as determined in DFPEI orders;
- (4) for contaminants, when milk is accepted by a bulk milk grader, but is later found to contain any contaminant that was not detectable by inspection or grading;
- (5) for farm inspection, when a producer fails an inspection as determined in DFPEI orders;
- (6) for inhibitors, when testing detects the presence of any inhibitor in milk that has been offered for sale; and
- (7) for somatic cells, when testing indicates the somatic cell count in milk is greater than that allowed in the DFPEI Raw Milk Standards Order.

Food safety  
infractions

8. (1) In the event an inspector determines that any infraction or dairy farm operating practice compromises, or has the potential to compromise, the safety of the milk produced on a farm for human consumption, the inspector may immediately prohibit the sale of milk from that farm until all food safety standards are met.

- (2) Notwithstanding any other penalty or restriction applied by this Order, where the milk of a producer is tested and found to contain contaminants or inhibitors, an inspector shall immediately place all milk on the premises under detention and prohibit the sale of milk from that dairy farm until the conditions for reinstatement are met.
- Added water  
violations and  
penalties
9. Added water (freezing point) violations occur when one infraction is recorded, except that the first infraction in any twelve-month period shall be excused. The following penalties shall apply for added water violations:
- (1) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (2) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (3) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
  - (4) for a fourth violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
    - b. the producer shall be prohibited from selling milk for a period of not less than six days;
  - (5) for the fifth violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
    - b. the producer shall be prohibited from selling milk for a period of not less than 12 days; and
  - (6) for the sixth or subsequent violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
    - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.
- Bacteria  
violations and  
penalties
10. Bacteria violations occur when three infractions are recorded in any period of two consecutive calendar months, with at least one of those infractions recorded in the last month of that two-month period. The following penalties shall apply for bacteria violations:
- (1) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;

- (2) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
- (3) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
- (4) for a fourth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
  - b. the producer shall be prohibited from selling milk for a period of not less than six days;
- (5) for the fifth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 12 days; and
- (6) for the sixth or subsequent violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.

Contaminant  
violations and  
penalties

11. Contaminant violations occur when any infraction is recorded. The following penalties shall apply for contaminant violations:
  - (1) When any contaminant violation occurs an inspector or other designated representative of DFPEI shall immediately prohibit sale of the milk from the farm and place any milk stored on the farm under detention until it is demonstrated that the source of contamination is eliminated and testing and or observation confirms the milk is free of contaminants;
  - (2) for all contaminant violations the producer shall be responsible for costs in accordance with s.17 of this order;
  - (3) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (4) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;



- (5) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
- (6) for a fourth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
  - b. the producer shall be prohibited from selling milk for a period of not less than six days and until the conditions of reinstatement have been met;
- (7) for the fifth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 12 days; and
- (8) for the sixth or subsequent violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.

proAction®  
violations and  
penalties

12. proAction® violations are recorded when an infraction occurs and is not corrected in the time permitted by the program, or as directed by a validator or inspector:
  - (1) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (2) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (3) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
  - (4) for a fourth violation or any subsequent violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
    - b. if the producer does not comply with proAction standard within 105 days of the date of validation the producer shall be prohibited from selling milk until the farm achieves a transitional registration as specified in the current DFPEI proAction® Order.

- Farm inspection violations and penalties
13. Farm inspection violations occur when an infraction is observed by an inspector and is not corrected in the time and manner permitted in DFPEI Orders, or as directed by an inspector:
- (1) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (2) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - (3) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
  - (4) for a fourth violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
    - b. the producer shall be prohibited from selling milk for a period of not less than six days;
  - (5) for the fifth violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
    - b. the producer shall be prohibited from selling milk for a period of not less than 12 days; and
  - (6) for the sixth or subsequent violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
    - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.
- Inhibitor violations and penalties
14. Inhibitor violations occur when one infraction is recorded. The following penalties shall apply for inhibitor violations:
- (1) When any inhibitor violation occurs an inspector or other designated representative of DFPEI shall immediately prohibit sale of the milk from the farm and place any milk stored on the farm under detention until it testing indicates that inhibitors are not present in the milk;
  - (2) for all inhibitor violations the producer shall be responsible for costs in accordance with s.16 of this order;
  - (3) for a first violation in a period of 12 consecutive months, the producer shall:

- a. be prohibited from selling milk until subsequent testing has proven the milk produced on the farm is free from inhibitors; and
  - b. pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
- (4) for a second violation in a period of 12 consecutive months, the producer shall:
- a. be prohibited from selling milk until subsequent testing has proven the milk produced on the farm is free from inhibitors; and
  - b. pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
- (5) for a third violation in a period of 12 consecutive months, the producer shall:
- a. pay four dollars (\$5) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
  - b. be prohibited from selling milk until subsequent testing has proven the milk produced on the farm is free from inhibitors; and
- (6) for a fourth violation in a period of 12 consecutive months:
- a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred, and
  - b. the producer shall be prohibited from selling milk for a period of not less than six days and until subsequent testing has proven the milk produced on the farm is free from inhibitors;
- (7) for the fifth violation in a period of 12 consecutive months:
- a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 12 days and until subsequent testing has proven the milk produced on the farm is free from inhibitors; and
- (8) for the sixth or subsequent violation in a period of 12 consecutive months:
- a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.

Somatic cell  
count violations  
and penalties

15. Somatic cell count violations occur when infractions are recorded from forty percent (40%) of the tests completed in any period of three consecutive calendar months, with at least one of those infractions recorded in the last month of that three-month period. The following penalties shall apply for somatic cell count violations:

- (1) for a first violation in a period of 12 consecutive months, the producer shall pay three dollars (\$3) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
- (2) for a second violation in a period of 12 consecutive months, the producer shall pay four dollars (\$4) per hL for all milk sold by the dairy farm during the month in which the violation occurred;
- (3) for a third violation in a period of 12 consecutive months, the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred;
- (4) for a fourth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than six days;
- (5) for the fifth violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 12 days; and
- (6) for the sixth or subsequent violation in a period of 12 consecutive months:
  - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 24 days.

Special  
circumstances

16. Where a contaminant or inhibitor violation occurs and it is determined the producer had knowledge of the contamination or presence of an inhibitor in the milk prior to it being offered for sale, the following penalties shall apply:
- (1) for all violations described in this section, the producer shall be responsible for costs in accordance with s.17 of this order;
  - (2) for a first violation in a period of 12 consecutive months:
    - a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
    - b. the producer shall be prohibited from selling milk for a period of not less than 12 days the producer shall be prohibited from selling milk for a period of not less than six days and until subsequent testing or observation has proven the milk produced on the farm is free from inhibitors or contaminants; and

- 
- 
- (3) for the second and subsequent violations in a period of 12 consecutive months:
- a. the producer shall pay five dollars (\$5) per hL for all milk sold by the farm during the month in which the violation occurred; and
  - b. the producer shall be prohibited from selling milk for a period of not less than 24 days and until subsequent testing or observation has proven the milk produced on the farm is free from inhibitors or contaminants.
- Cost for Damages 17. In the event the milk from a farm is determined to be contaminated by an inhibitor or any other contaminant and the contamination could not be determined by the bulk milk grader at the time of pick up, the producer shall be responsible for the cost of all resulting damages, including but not limited to:
- (1) the revenue due to all other producers for milk contained in the load or compartment that has been contaminated;
  - (2) the regular transportation cost for the contaminated milk;
  - (3) any transportation cost for delivery of the contaminated milk for disposal;
  - (4) any cost for disposal of the contaminated milk; and
  - (5) any other cost directly attributable to handling and disposal of the contaminated milk.
- Reinstatement 18. The following requirements must be met for a producer to be permitted to sell milk following a prohibition applied as indicated in this order:
- (1) for a prohibition applied under section 5(3) of this order the requirement for reinstatement shall be a determination by the animal welfare officer or an inspector or representative designated by DFPEI that the circumstances that caused the animals on the farm to be in distress have been corrected and the farm is in compliance with all standards for animal care applicable in the AWA or the Code of Practice;
  - (2) for a prohibition applied under sections 9(4), 10(4), 11(6), 13(4), 14(6) or 15(4) of this order, an official sample of milk from the farm must pass all current standards as determined by grading and testing the milk;
  - (3) for a prohibition applied under sections 9(5), 10(5), 11(7), 12(5), 13(5), or 15(5) of this order:
    - a. an official sample of milk from the farm must pass all current standards as determined by grading and testing the milk; and
    - b. the farm must pass a farm inspection;
  - (4) for a prohibition applied under sections 14(7) or 16(2) of this order:
    - a. an official sample of milk from the farm must pass all current standards as determined by grading and testing the milk;
    - b. the farm must have passed a farm inspection completed not more than 3 months prior to the date the prohibition was ordered;

- c. the farm must pass a proAction® validation; and
- (5) for a prohibition applied under sections 9(6), 10(6), 11(8), 12(6), 13(6), 14(8), 15(6) or 16(3) of this order:
- a. an official sample of milk from the farm must pass all current standards as determined by grading and testing the milk;
  - b. the farm must have passed a farm inspection completed not more than 3 months prior to the date the prohibition was ordered;
  - c. the farm must have passed a proAction® validation completed not more than three months prior to the date the prohibition was ordered;
  - d. the producer must appear before the Board or a committee of the Board to provide evidence of what special circumstances contributed to the repeated violations and present a viable action plan to ensure that no more violations will occur on their farm; and
  - e. the Board review the circumstances and any recommendations provided by a committee of the Board to determine if the farm may be permitted to resume selling milk.

Reinstatement  
costs

19. Any additional costs incurred by DFPEI for reinstatement of a producer who has been prohibited from selling milk shall be for the account of the farm seeking reinstatement. These costs include but not limited to:
- (1) the cost of additional inspections or validations or other required farm visits to ensure compliance;
  - (2) the time and travel costs incurred for an inspector to obtain and deliver additional official samples required for reinstatement; and
  - (3) the cost of any additional laboratory testing required for reinstatement.

Revocation 20. DFPEI Order 2017-10 is hereby revoked.

Commencement 21. This order shall come into force on the 28th day of July 2023.
