**2. Referral to youth justice court judge**

Where a judicial justice of the peace considers that any matter over which the judicial justice of the peace has jurisdiction pursuant to subsection 2(3) of the *Youth Justice Act* R.S.P.E.I. 1988, Cap. Y-3, would best be dealt with before a youth justice court judge, the judicial justice of the peace shall refer the matter to a youth justice court judge.

**2. These regulations come into force on September 2, 2023.**

**EXPLANATORY NOTES**

**SECTION 1** revokes section 2 of the *Justice of the Peace Act* Regulations and substitutes a new section 2 to clarify the authority and responsibility of a judicial justice of the peace in dealing with matters under subsection 2(3) of the *Youth Justice Act*.

  - (a) **in the words preceding clause (a), by the deletion of the words “An application” and the substitution of the words “Notwithstanding any other enactment, an application”; and**
  - (b) **in clause (b), by the deletion of the words “considers necessary.” and the substitution of the words “considers necessary, including but not limited to the Minister’s written approval to proceed with the undertaking under subsection 9(1) of the *Environmental Protection Act* R.S.P.E.I. 1988, Cap. E-9.”.**
2. **These regulations come into force on September 2, 2023.**

**EXPLANATORY NOTES**

**SECTION 1** amends subsection 3(1) of the Development Permit Regulations (EC773/08) made under the *Renewable Energy Act* R.S.P.E.I. 1988, Cap. R-12.1, to clarify that notwithstanding any other enactment that purports to provide an application process for a development permit, the application process for a development permit for the purposes of the *Renewable Energy Act* is that set out in section 3 of the regulations. The section also adds to clause 3(1)(b) of the regulation an explicit requirement for an applicant to submit, along with the application for the development permit, a written approval issued under subsection 9(1) of the *Environmental Protection Act* to proceed with the undertaking.

**SECTION 2** provides for the commencement of these regulations.
