In Testimony Whereof We have caused these Our Letters to be made Patent and the Great Seal of the Province of Prince Edward Island to be hereunto affixed.

Witness, Our Trusty and Well Beloved, Antoinette Perry, Chancellor of Our Order of Prince Edward Island, Lieutenant Governor in and of Our Province of Prince Edward Island.

**Given** at our Government House in Charlottetown, this twelfth day of September in the year of Our Lord two thousand and twenty-two and in the first year of Our reign.

#### COVID-19 PREVENTION AND SELF-ISOLATION ORDER

TO: All persons residing in or present in Prince Edward Island; and

All businesses, services and organizations operating or carrying on business in Prince Edward Island

**AND WHEREAS** in consultation with the Lieutenant Governor in Council, I believe it is reasonably necessary to impose requirements in Prince Edward Island ("the Province") in order to protect the health of the population;

**AND WHEREAS** pursuant to subsection 39(1) of the Act, I, as the Chief Public Health Officer, may require a person to take or refrain from taking any action that is specified in this Order in respect of a communicable disease;

**AND WHEREAS** I, as the Chief Public Health Officer, pursuant to subsection 39(2) of the Act, believe on reasonable and probable grounds that:

- (a) a communicable disease, COVID-19, including any new variants of the virus causing COVID-19, exists or may exist in the Province;
- (b) the communicable disease presents a risk to the health of persons in the Province; and
- (c) the requirements specified in this Order are necessary to prevent, decrease or eliminate the risk to health presented by the communicable disease;

**AND WHEREAS** the reasons for this Order are the global COVID-19 pandemic, the health risks posed by the pandemic, including health risks posed by new variants of the virus causing COVID-19, and the necessity to prevent, decrease or eliminate those health risks;

**AND WHEREAS** isolating individuals who test positive for COVID-19, and any variants of concern, will prevent transmission of the virus and the associated illness and death and protect Prince Edward Island's health care system;

AND WHEREAS I recognize the effect which the requirements I am putting in place to protect the health of the public have on persons in PEI and, with this in mind, have engaged and will continue to engage in a process of reconsideration of these requirements, based upon the information and evidence available to me, including infection rates, sources of transmission, the presence of clusters and outbreaks, the number of people in hospital and in intensive care, deaths, the emergence of and risks posed by virus variants of concern, vaccine availability, immunization rates, the vulnerability of particular populations, and reports from the rest of Canada and other jurisdictions, with a view to balancing the interests of the people affected by this Order, including constitutionally protected interests, against the risk of harm to the public health;

**AND WHEREAS** I issued previous public health orders that are no longer in effect, including a Long-Term Care and Nursing Homes COVID-19 Order, and there is an increased risk of severe COVID-19 outcomes, such as hospitalizations and deaths, among the population of certain health facilities such as long-term care facilities and nursing homes;

**AND WHEREAS** pursuant to subsection 56(1) of the Act, I, as the Chief Public Health Officer, may require any person to provide information that the Chief Public Health Officer reasonably considers necessary to:

(a) assess the threat that a disease presents to public health and plan for and address the threat; or

(b) evaluate and monitor the health and safety of the general public;

**AND WHEREAS** pursuant to section 60 of the Act, a public health official may request assistance from a peace officer in conducting an inspection, investigation, inquiry, search or in enforcing an order made under the Act;

**AND WHEREAS** pursuant to subsection 61(4) of the Act, no person shall knowingly provide false or misleading information, either orally or in writing, to a public health official;

**NOW THEREFORE**, pursuant to my authority under sections 39 and 56 of the Act, I hereby order as follows:

#### **Definitions**

- 1. In this Order:
  - (a) "close contact" means:
    - A person who had face-to-face interaction, indoors or outdoors, for at least 15 minutes (including 15 minutes in total over a 24-hour period) with a person with COVID-19 during the infectious period of the person with COVID-19;
    - (ii) A person who was within two metres indoors for at least 15 minutes (including 15 minutes in total over a 24-hour period) with a person with COVID-19 during the infectious period of the person with COVID-19;
    - (iii) A person who comes into direct contact with the body or infectious body fluids (for example: a hug, cough or sneeze) of a person with COVID-19 during the infectious period of the person with COVID-19; or
    - (iv) A person who is exposed to COVID-19 in such other conditions as determined by the Chief Public Health Officer,

but does not include:

- A. a person who consistently and appropriately uses personal protective equipment while caring for a person with COVID-19; or
- B. a person who has contact described in sub-clauses (i) to (iii) where the person with COVID-19 was wearing a mask throughout the contact period.
- (b) "COVID-19 antigen test" means a COVID-19 screening or diagnostic immunoassay that:
  - (i) detects the presence of a viral antigen indicating the presence of COVID-19; and
  - iii authorized for sale or distribution in Canada or in the jurisdiction in which it was obtained.
- (c) "COVID-19 molecular test" means a COVID-19 screening or diagnostic test, including a test performed using the method of polymerase chain reaction (PCR), nucleic acid test (NAT), nucleic acid amplification (NAAT) or reverse transcription loop-mediated isothermal amplification (RT-LAMP).
- (d) "facility" means the following establishments:

- community care facilities as defined in clause 1(d) of the Community Care Facilities and Nursing Homes Act, RSPEI 1988, Cap. C-13;
- (ii) community hospitals and provincial hospitals, both as defined in clauses 1(1)(b) and 1(1)(g) of the Hospitals Act, RSPEI 1988 Cap. H-10.1, respectively;
- (iii) long term care facilities which are operated by or on behalf of the Department of Health and Wellness or Health PEI: and
- (iv) nursing homes as defined under clause 1(j) of the Community Care Facilities and Nursing Homes Act;
- (e) "infectious period" means, in relation to an individual who is a person with COVID-19, the period of time that starts 48 hours prior to onset of that person's symptoms, or if the person with COVID-19 does not have symptoms of COVID-19, 48 hours prior to when that person received their initial positive test result for COVID-19 and ends at least 7 days after the onset of COVID-19 symptoms or at least 7 days after the date of their initial positive COVID-19 test, whichever is the earlier date, and for such additional time as indicated by a public health official.
- (f) "mask" means any mask, including a non-medical mask, that meets all of the following requirements:
  - it is made of at least three multiple layers of tightly woven material such as cotton or linen or is a medical-grade mask;
  - (ii) it completely covers a person's nose, mouth and chin without gaping; and
  - (iii) it can be secured to a person's head with ties or ear loops.
- (g) "operator", for the purposes of this Order, includes an owner.
- (h) "person with COVID-19", for the purposes of this Order, means a person who has received a positive test result for COVID-19 using a COVID-19 antigen test or a COVID-19 molecular test.
- (i) "self-isolate" means compliance with the following requirements:
  - (i) A person must remain in their residence or residence grounds, except to seek medical care or due to extraordinary circumstances including reasons of personal safety. A person who resides in an apartment building, condominium, rental accommodation, rooming house, or other attached housing must remain on the residence's property and maintain a two-metre distance from other persons at all times while in common areas, corridors, stairwells, elevators, other shared spaces, and outdoors;
  - (ii) If a person must leave their residence or the residence's property for a reason outlined in sub-clause (i), the person must maintain a two-metre distance from other persons at all times, other than during treatment by a health care worker; and
  - (iii) all additional self-isolation requirements published at: https://www.princeedwardisland.ca/en/information/health-and-wellness/covid-19-self-isolation.

#### **Mandatory Self-Isolation**

- 2. Unless otherwise directed by a public health official, persons residing in or present in Prince Edward Island who fall under any of the categories below shall follow the requirements and self-isolate for the periods of time specified here:
  - (a) Persons who:
    - (i) are persons with COVID-19;
    - (ii) are persons who cannot isolate away from an individual identified in (i); or
    - (iii) are close contacts who have symptoms of COVID-19, except as outlined in (c);
      - A. must self-isolate for a period of at least 5 days after the onset of COVID-19 symptoms or at least 5 days after the date of their initial positive COVID-19 antigen or molecular test, whichever is the earlier date, and for such additional time as indicated by a public health official (including 10 days for immunocompromised individuals and other individuals as outlined at: https://www.princeedwardisland.ca/en/information/health-and-wellness/information-for-people-who-have-tested-positive-for-covid-19); and
      - B. if they leave isolation after 5 days, must wear a mask for the next 5 days in all indoor public places and in all indoor settings (including workplaces, schools or public transportation) where physical distancing of more than two metres cannot be maintained from other persons;
  - (b) Persons who isolated in accordance with (a)(i) but who:
    - experience a return of symptoms of COVID-19 within 8 days of recovering from symptoms of COVID-19; and
    - (ii) test positive for COVID-19 by a COVID-19 antigen test after the return of COVID-19 symptoms;

must self-isolate for a period of at least 5 days after the date of the return of COVID-19 symptoms or for such additional time as indicated by a public health official as outlined at https://www.princeedwardisland.ca/en/information/health-and-wellness/information-for-people-who-have-tested-positive-for-covid-19;

- (c) Persons identified in (a)(iii):
  - (i) who receive a negative COVID-19 molecular test result from a Health PEI clinic may exit isolation at an earlier date than applicable to them under (a), but these persons should continue to be tested for COVID-19 at a Health PEI clinic if they continue to have symptoms of COVID-19 after receiving the negative COVID-19 molecular test result; or
  - (ii) who tested positive for COVID-19 (by a COVID-19 molecular test at a Health PEI clinic or as determined by a public health official) and completed their isolation period in the 60 (sixty) days previous to being a close contact do not need to isolate in accordance with (a) but must monitor for symptoms of COVID-19 and, if symptomatic, self-isolate until symptoms resolve or are improving;

(d) Persons not identified in (a), (b) or (c) who are symptomatic for COVID-19 and awaiting the results of a COVID-19 antigen test or COVID-19 molecular test shall self-isolate until they receive a negative test result.

#### Masking Requirements - Certain Facilities

- 3. Except as outlined in section 4, all persons must wear a mask while present in:
  - (a) a facility; or
  - (b) a setting listed on the Chief Public Health Officer's List of Settings Where Masks are Required, which list will be publicly released, amended and updated by the Chief Public Health Officer as necessary to prevent or decrease the risk to health presented by COVID-19.
- 4. The following persons are exempt from the requirement to wear a mask while present in a facility or a setting referenced in section 3:
  - (a) a person who is less than 2 years of age;
  - (b) a person who is age 2 to 5 years and will not wear a mask;
  - (c) a person for whom the wearing of a mask is not possible because of the person's medical condition;
  - (d) a person who cannot remove their mask without assistance;
  - (e) a person who is reasonably accommodated by not wearing a mask in accordance with the *Human Rights Act*, R.S.P.E.I 1988, Cap. H-12;
  - (f) a person who removes the mask momentarily for identification or ceremonial purposes;
  - (g) a person who is in the facility receiving care or being provided a service or while participating in
    a physical or other activity requiring the mask be removed, in which case the person may remove
    the mask for the duration of the care, service or activity;
  - (h) a person who is consuming food or a beverage; and
  - a person who resides at a facility, except in situations where the Chief Public Health Officer issues Guidance applicable to residents of their facility.

#### **Child Care and Schools**

- 5. Operators of licensed child care centres and unlicensed child care centres must comply with the Chief Public Health Officer's Licensed Child Care Centre Guidance and Chief Public Health Officer's Unlicensed Child Care Centre Guidance as applicable to them, which Guidance documents may be amended by the Chief Public Health Officer from time to time.
- 6. All kindergarten—grade 12 public and private schools in the Province, when offering in-person learning, must comply with the Prince Edward Island COVID-19 Back to School Public Health Guidance for Public and Private Kindergarten to Grade 12 Schools 2022—23 as applicable to them, which Guidance document may be amended by the Chief Public Health Officer from time to time.

#### General

- 7. Notwithstanding anything in this Order, the Chief Public Health Officer may on written request by a person sent to the Office of the Chief Public Health Officer at the address noted below with the subject line Request for COVID-19 Prevention and Self-isolation Order Exemption:
  - (a) exempt a person or class of persons from the application of any section of this Order under exceptional circumstances or on reasonable grounds; and
  - (b) impose, on any person or class of persons being exempted from the application of any section of this Order under clause (a), public health requirements consistent with this Order to minimize the risk of introduction or spread of COVID-19.
- For greater certainty, nothing in this Order limits the operation of the Act or its regulations or restricts
  the ability of the Chief Public Health Officer to issue public health orders or other orders or directives,
  as necessary.
- This Order:
  - (a) is effective on September 9, 2022 at 12:00 a.m., revoking and replacing my Order of August 12, 2022; and
  - (b) shall remain in effect until October 6, 2022 at 11:59 p.m., unless earlier amended or revoked by the Chief Public Health Officer if the requirements specified in this Order are no longer necessary to prevent, decrease or eliminate the risk to health presented by the communicable disease.

# **EMPLOYMENT STANDARDS ACT**

# GENERAL REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 13, 2022.)

2. These regulations come into force on September 17, 2022.

# LICENSED PRACTICAL NURSE REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 13, 2022.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

- 1. Subsection 18(1) of the *Regulated Health Professions Act* Licensed Practical Nurse Regulations (EC150/18) is amended:
  - (a) in clause (c), by the deletion of the period and the substitution of a semi-colon; and
  - (b) by the addition of the following after clause (c):
  - (d) applying sound energy or electrical energy, other than ionizing radiation;
  - (e) applying electrical energy in the form of ionizing radiation to conduct an X-ray for the purpose of dental screening, diagnosis or treatment.
- 2. These regulations come into force on September 17, 2022.

# **EXPLANATORY NOTES**

**SECTION 1** amends subsection 18(1) of the regulations to authorize licensed practical nurses to perform additional reserved activities.

**SECTION 2** provides for the commencement of these regulations.

# EC2022-709

# REGULATED HEALTH PROFESSIONS ACT MIDWIVES REGULATIONS

(Approved by Her Honour the Lieutenant Governor in Council dated September 13, 2022.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

# PART 1 – INTERPRETATION AND DESIGNATION

#### 1. Definitions

In these regulations

- (a) "Act" means the Regulated Health Professions Act R.S.P.E.I. 1988, Cap. R-10.1;
- (b) "College" means the College of Registered Nurses and Midwives of Prince Edward Island continued under the Registered Nurses Regulations (EC350/18);
- (c) "Council" means the Council of the College;
- (d) "midwife" means a member who is registered in the register for midwifery;
- (e) "**midwifery**" means the health profession in which a person applies particular knowledge, skills and judgment in
  - (i) pre-conception care,
  - (ii) the care, assessment and monitoring of pregnant clients and babies during pregnancy, labour and the post-partum period, and
  - (iii) the management of spontaneous vaginal deliveries;
- (f) "post-partum period" means the eight-week period immediately following the birth of a baby;
- (g) "**refresher program**" means a refresher program in midwifery consisting of a formal curriculum, a set of individualized assignments of studies and experiences, a set of continuing education credits, a practicum or a combination of these elements.

#### 2. Designation of midwifery

Midwifery is designated as a regulated health profession.

#### **PART 2 – REGISTRATION**

# Register

# 3. Parts of register

The register for midwifery is divided into the following parts:

- (a) general registration;
- (b) provisional registration;
- (c) special registration.

# **General Registration**

#### 4. General registration

- (1) The registrar shall register an applicant in the general registration part where
  - (a) the registrar is satisfied that the applicant meets all the requirements for registration set out in subsection 12(2) of the Act and these regulations and registers the applicant pursuant to subsection 12(3) of the Act; or
  - (b) the Council directs the registrar to register the applicant in the general registration part pursuant to subsection 12(6) of the Act or reinstate the registration of the applicant in the general registration part pursuant to subsection 24(4) of the Act.

#### Reinstatement period

(2) For the purpose of subsection 24(1) of the Act, a midwife may apply for reinstatement of registration in the general registration part within three years after a lapse in the registration.

# 5. Education

For the purpose of clause 12(2)(d) of the Act, the requirements with respect to education are the successful completion of

- (a) either
  - (i) a baccalaureate program in midwifery offered by an accredited post-secondary institution in Canada, approved by the Council, or
  - (ii) education or training the Council considers substantially equivalent to a program described in subclause (i);
- (b) a course on fetal health surveillance, approved by the Council; and
- (c) a course on prescribing and administering controlled drugs and substances, approved by the Council.

#### 6. Examinations

For the purpose of clause 12(2)(d) of the Act, the required examinations are

- (a) a provincial examination established or adopted by the Council to assess knowledge and understanding of the jurisprudence, ethical standards and standards of practice governing the practice of midwifery in the province; and
- (b) the Canadian Midwifery Registration Examination or other competency examination approved by the Council.

# 7. Currency requirements

For the purposes of clause 12(2)(f), subclause 22(2)(a)(ii) and clause 24(4)(c) of the Act, an applicant shall have done one of the following within the four years immediately preceding the date of the application to demonstrate currency of professional knowledge and skills:

- (a) successfully completed the educational requirement set out in section 5;
- (b) actively practised midwifery without any restrictions for at least 1,000 hours and attended at least 30 births;
- (c) successfully completed a refresher program satisfactory to the registrar.

#### 8. Insurance requirements

For the purposes of clause 12(2)(j), subclause 22(2)(a)(v) and clauses 24(4)(f) and 25(3)(c) of the Act, an applicant or a member registered under these regulations, as the case may be, is required to hold or be covered by professional liability insurance under a policy that provides coverage of not less than \$35,000,000 per claim or occurrence and an aggregate limit of not less than \$35,000,000 excluding legal or court costs.

#### 9. Additional qualifications

For the purposes of clause 12(2)(k), subclause 22(a)(v.1) and clause 24(4)(g), an applicant shall have up-to-date certification, approved by the Council, in

- (a) neonatal resuscitation;
- (b) cardiopulmonary resuscitation; and
- (c) obstetrical emergency skills.

#### 10. Continuing education and competency

For the purpose of subclause 22(2)(a)(i) of the Act, an applicant shall fulfil the requirements for continuing education and competency established by the Council pursuant to sections 60 and 60.1 of the Act.

# **Provisional Registration**

# 11. Provisional registration

(1) Where an applicant for registration under section 12 of the Act, or the renewal or reinstatement of registration in the general registration part under section 22 or 24 of the Act, does not meet the requirements for currency of professional knowledge and skills, the Council may direct the registrar to register the applicant in the provisional registration part, subject to the term or condition that the applicant successfully completes a refresher program approved by the Council, within a specified time period.

#### Satisfaction of term or condition

(2) Where a midwife satisfies the term or condition imposed under subsection (1), the registrar shall register, or renew or reinstate the registration of, the midwife in the general registration part.

#### Subject to supervision

(3) A midwife registered in the provisional registration part shall be supervised in practising midwifery by a midwife registered in the general registration part, approved by the Council.

### No renewal or reinstatement

(4) Registration in the provisional registration part may not be renewed or reinstated.

# **Special Registration**

# 12. Special registration

(1) Where the Council directs the registrar to register an applicant pursuant to subsection 13(3) of the Act, the registrar shall register the applicant in the special registration part.

### No renewal or reinstatement

(2) Registration in the special registration part may not be renewed or reinstated.

#### PART 3 – DESIGNATIONS AND RESERVED ACTIVITIES

# 13. Designations of members

For the purpose of subsection 89(1) of the Act, the designations of a midwife include

- (a) midwife;
- (b) registered midwife; and
- (c) RM or R.M.

#### 14. Reserved activities

- (1) Subject to subsection (4) and any terms or conditions imposed on the midwife's registration, a midwife is authorized to perform the following reserved activities:
  - (a) communicating to a person or the person's personal representative a diagnosis identifying a disease or disorder as the cause of symptoms of the person in circumstances in which it is reasonably foreseeable that the person or the person's personal representative will rely on the diagnosis;
  - (b) performing any of the following procedures on tissue below the dermis or below the surface of a mucous membrane:
    - (i) an episiotomy or amniotomy, or the repair of an episiotomy or lacerations not involving the anus, anal sphincter, rectum or urethra,
    - (ii) venepuncture or a skin prick to obtain a blood sample,
    - (iii) intravenous cannulation;
  - (c) administering a substance by injection, transfusion, inhalation, mechanical ventilation, irrigation, topical means or enteral or parenteral instillation;
  - (d) putting an instrument, hand or finger
    - (i) beyond the point in the nasal passages where they normally narrow, for the purpose of suctioning a newborn.
    - (ii) beyond the opening of the urethra, for the purpose of bladder catheterization,
    - (iii) beyond the labia majora, for the purpose of
      - (A) conducting an internal examination or amniotomy,
      - (B) fitting, inserting or removing a contraceptive device.
      - (C) applying internal fetal electrodes,

- (D) collecting swabs or smears for diagnostic testing, or
- (E) cervical ripening;
- (iv) beyond the anal verge, for the purpose of
  - (A) assessing perineal repair,
  - (B) administering a drug, or
  - (C) collecting a rectal swab for a culture;
- (e) prescribing and administering the drugs or classes of drugs set out in the Schedule to these regulations;
- (f) prescribing and administering to a client 18 years of age or older, a vaccine recommended in the Canadian Immunization Guide published by the Public Health Agency of Canada;
- (g) prescribing and administering a vaccine for Hepatitis B to an infant birthed by a client who is Hepatitis B positive;
- (h) administering a vaccine prescribed by the Chief Public Health Officer;
- (i) applying or ordering the application of sound energy for the purpose of monitoring a pregnant client and fetus;
- (j) applying or ordering the application of electrical energy in the form of phototherapy in a hospital;
- (k) managing labour and conducting the delivery of a baby;
- (l) ordering and interpreting screening and diagnostic tests that do not use prescribed forms of energy.

# Reserved activities, emergency

- (2) Subject to subsection (4) and any terms or conditions imposed on the midwife's registration, a midwife is authorized to perform the following reserved activities in an emergency:
  - (a) putting an instrument, hand or finger
    - (i) beyond the larynx, for the purpose of
      - (A) intubating a neonate, or
        - (B) placing a laryngeal mask airway in a neonate,
    - (ii) beyond the labia majora, for the purpose of
      - (A) inserting a uterine tamponade,
      - (B) manually extracting the placenta, or
      - (C) bimanual clot evacuation:
  - (b) performing a procedure on tissue below the dermis or the surface of a mucous membrane for the purpose of umbilical venous catheterization.

# Special authorization for reserved activity

(3) On application the registrar may grant to a midwife who has completed a course on surgical first assist for a caesarean section, approved by the Council, special authorization to perform a procedure on tissue below the dermis for the purpose of electrocautery, wound closure and suturing.

#### **Terms and conditions**

- (4) On performing any reserved activity, a midwife shall ensure
  - (a) the midwife has reasonable access to a medical practitioner or nurse practitioner in respect of the client for the purposes of consultation, referral or transfer; and
  - (b) where the midwife is attending a birth, there is a second attendant present who has the following qualifications:
    - (i) up-to-date certification in neonatal resuscitation and cardiopulmonary resuscitation, approved by the Council;
    - (ii) training in neonatal and obstetrical emergencies, approved by the Council.

#### PART 4 – GENERAL

#### 15. Name of corporation

(1) For the purpose of clause 15(1)(d) of the Act, the name of a corporation applying for a permit to carry on the business of providing the professional services of a midwife shall be, in the opinion of the registrar, in good taste, dignified and professional.

# Change of name

(2) Before changing its name, a health profession corporation shall obtain written confirmation from the registrar that the proposed name meets the requirements of subsection (1).

#### 16. Commencement

These regulations come into force on September 17, 2022.

- 2. Section 3 of the regulations is revoked and the following substituted:
- 3. Continuation of College as multidisciplinary college

The College of Registered Nurses of Prince Edward Island, a body corporate continued as the college for nursing under this section as it read on July 4, 2018, is continued as the college for nursing and midwifery under the name College of Registered Nurses and Midwives of Prince Edward Island.

- 3. Subsection 21(1) of the regulations is amended by the addition of the following after clause (d):
  - (d.1) applying sound energy or electrical energy, other than ionizing radiation;
  - (d.2) apply electrical energy in the form of ionizing radiation to conduct an X-ray for the purpose of dental screening, diagnosis or treatment;
- 4. Clauses 23(1)(b), (c) and (d) of the regulations are revoked and the following substituted:
  - (b) ordering the application of sound energy or electrical energy, other than ionizing radiation;
  - (c) ordering the application of electrical energy in the form of ionizing radiation to conduct an X-ray or a computed tomography scan;

5. These regulations come into to force on September 17, 2022.

# **EXPLANATORY NOTES**

**SECTION 1** amends the definition of "College" to reflect the new name of the College in accordance with the new section 3 of the regulations.

**SECTION 2** revokes and replaces section 3 of the regulations to continue the College of Registered Nurses of Prince Edward Island as the college for nursing and midwifery under the name College of Registered Nurses and Midwives of Prince Edward Island.

**SECTION 3** amends subsection 21(1) of the regulations to authorize registered nurses to perform additional reserved activities.

**SECTION 4** amends subsection 23(1) to update the reserved activities nurse practitioners are authorized to perform in respect of forms of energy.

**SECTION 5** provides for the commencement of these regulations.

- (3) Notwithstanding subsection (1), the Minister shall ensure that there are at least 194, but not more than 197, school days in the school year commencing in 2022 and ending in 2023, to provide for a day of mourning for Her Majesty Queen Elizabeth II on September 19, 2022.
- 2. The regulations are amended by the addition of the following after section 8:

#### 8.1 Day of Mourning

The day of September 19, 2022, a day of mourning for Her Majesty Queen Elizabeth II, shall not be an instructional day or a school day.

3. These regulations come into force on September 17, 2022.

#### **EXPLANATORY NOTES**

**SECTION 1** adds a new subsection 2(3) to the regulations to allow one less school day in the 2022-2023 school year to provide for the observance of a day of mourning for Her Majesty Queen Elizabeth II on September 19, 2022.

**SECTION 2** adds a new section 8.1 to the regulations to provide that the day of mourning for Her Majesty Queen Elizabeth II, to be held on September 19, 2022, shall not be an instructional day or a school day.

**SECTION 3** provides for the commencement of these regulations.
