**REGULATED HEALTH PROFESSIONS ACT
PHARMACIST AND PHARMACY TECHNICIAN
REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated September 22, 2020.)

Pursuant to sections 2 and 96 of the *Regulated Health Professions Act* R.S.P.E.I. 1988, Cap. R-10.1, Council made the following regulations:

- 1. Clause 29(1)(b) of the *Regulated Health Professions Act Pharmacist and Pharmacy Technician Regulations (EC445/19)* is amended by the deletion of the words “in person”.**
- 2. Schedule C to the regulations is amended by the addition of the following after clause (aa):**
 - (aa.1) uncomplicated cystitis (urinary tract infection);
- 3. These regulations come into force on October 3, 2020.**

EXPLANATORY NOTES

SECTION 1 removes the requirement that a pharmacist assess a patient in person before giving the patient a prescription.

SECTION 2 adds uncomplicated cystitis (urinary tract infection) to the list of minor ailments for which a pharmacist may give a prescription.

SECTION 3 provides for the commencement of these regulations.

FUR HARVESTING REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated September 22, 2020.)

Pursuant to section 28 of the *Wildlife Conservation Act* R.S.P.E.I. 1988, Cap. W-4.1, Council made the following regulations:

1. (1) Subsection 2(4) of the *Wildlife Conservation Act* Fur Harvesting Regulations (EC663/04) is revoked and the following substituted:

Trapper registration
number

(4) The Department shall, in respect of each person who is issued a trapping license, assign to the person a permanent trapper registration number, which shall be a letter and number combination or a combination of letters that is unique to each such person.

(2) Subsection 2(5) of the regulations is amended by the deletion of the words “using the metal dies issued to the person by the Department under subsection (4)”.

2. Schedule C to the regulations is revoked and Schedule C as set out in the Schedule to these regulations is substituted.

3. These regulations come into force on October 3, 2020.

EXPLANATORY NOTES

SECTION 1 amends the *Wildlife Conservation Act* Fur Harvesting Regulations (EC663/04) by revoking subsection 2(4) and substituting a new subsection 2(4) that authorizes the Department to issue trapper registration numbers. The amendment eliminates a requirement for the Department to also issue metal dies for stamping the number on traps, which is no longer necessary. The section also amends subsection 2(5) of the regulations, which contains a reference to the metal dies.

SECTION 2 revokes Schedule C to the regulations and substitutes a new Schedule C with an updated list of approved body-gripping traps.

SECTION 3 provides for the commencement of the regulations.
