EDUCATION ACT

**EDUCATION AUTHORITY REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated October 4, 2022.)

Pursuant to section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

1. **Subsection 3(2) of the *Education Act* Education Authority Regulations (EC524/16) is revoked and the following substituted:**

Exception for 2022

- (2) The term of office of a trustee
 - (a) of the Public Schools Branch elected or appointed pursuant to the education authority election in 2022 commences on January 1, 2023, and ends on October 31 of the next year in which an education authority election is held; and
 - (b) of the French Language School Board elected or appointed pursuant to the education authority election in 2022 commences 10 days after election day and ends on October 31 of the next year in which an education authority election is held.

2. **These regulations come into force October 8, 2022.**

EXPLANATORY NOTES

SECTION 1 revokes and replaces subsection 3(2) of the *Education Act* Education Authority Regulations (EC524/16) to delete a reference to the date of October 21, 2022, and to clarify the terms of office of trustees elected in 2022. Due to exigent circumstances, the Chief Electoral Officer is authorized under the Election Regulations (EC525/16) to specify a different date for the elections in 2022. Trustees of the Public Schools Branch take office on January 1, 2023. Trustees of

the French Language School Board take office 10 days after the election day specified by the Chief Electoral Officer.

SECTION 2 provides for the commencement of these regulations.

EDUCATION ACT

**ELECTION REGULATIONS
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated October 4, 2022.)

Pursuant to section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

1. **Section 1 of the *Education Act* Election Regulations (EC525/16) is amended**
 - (a) **in clause (d.1), by the addition of the words “, and, in 2022, means a date specified by the Chief Electoral Officer” after the word “October”; and**
 - (b) **in clause (f.1), by the addition of the words “, and, in 2022, means the election period specified by the Chief Electoral Officer” after the word “authorities”.**
2. (1) **Subsection 2(1) of the regulations is amended by the deletion of the words “Subject to subsection (2)” and the substitution of the words “Subject to subsections (1.1) and (2)”.**
- (2) **Section 2 of the regulations is amended by the addition of the following after subsection (1):**

Exception - 2022

- (1.1) Notwithstanding subsections (1), 8(2) and 10(3), due to exigent circumstances, the elections for trustees of an education authority in 2022 shall be held on the date specified by the Chief Electoral Officer.

Notice of date

- (1.2) The Chief Electoral Officer shall give notice of the date referred to in subsection (1.1) in accordance with clause 8(1)(g) or by any other means the Chief Electoral Officer considers effective for the purpose.

- 3. These regulations come into force on October 8, 2022.**

EXPLANATORY NOTES

SECTION 1 amends clauses (d.1) and (f.1) of section 1 of the *Education Act* Election Regulations (EC525/16) to acknowledge that the Chief Electoral Officer is permitted to change the date of the education authority elections in 2022, due to exigent circumstances.

SECTION 2 adds new subsections 2(1.1) and (1.2) to the regulations to authorize the Chief Electoral Officer to specify a date on which the education authority regulations shall be held in 2022, due to exigent circumstances. The new election date to be specified by the Chief Electoral Officer is an exception to and does not change the general rules respecting election dates in subsection 2(1) and the timing of nomination day in subsection 10(3).

SECTION 3 provides for the commencement of these regulations.
