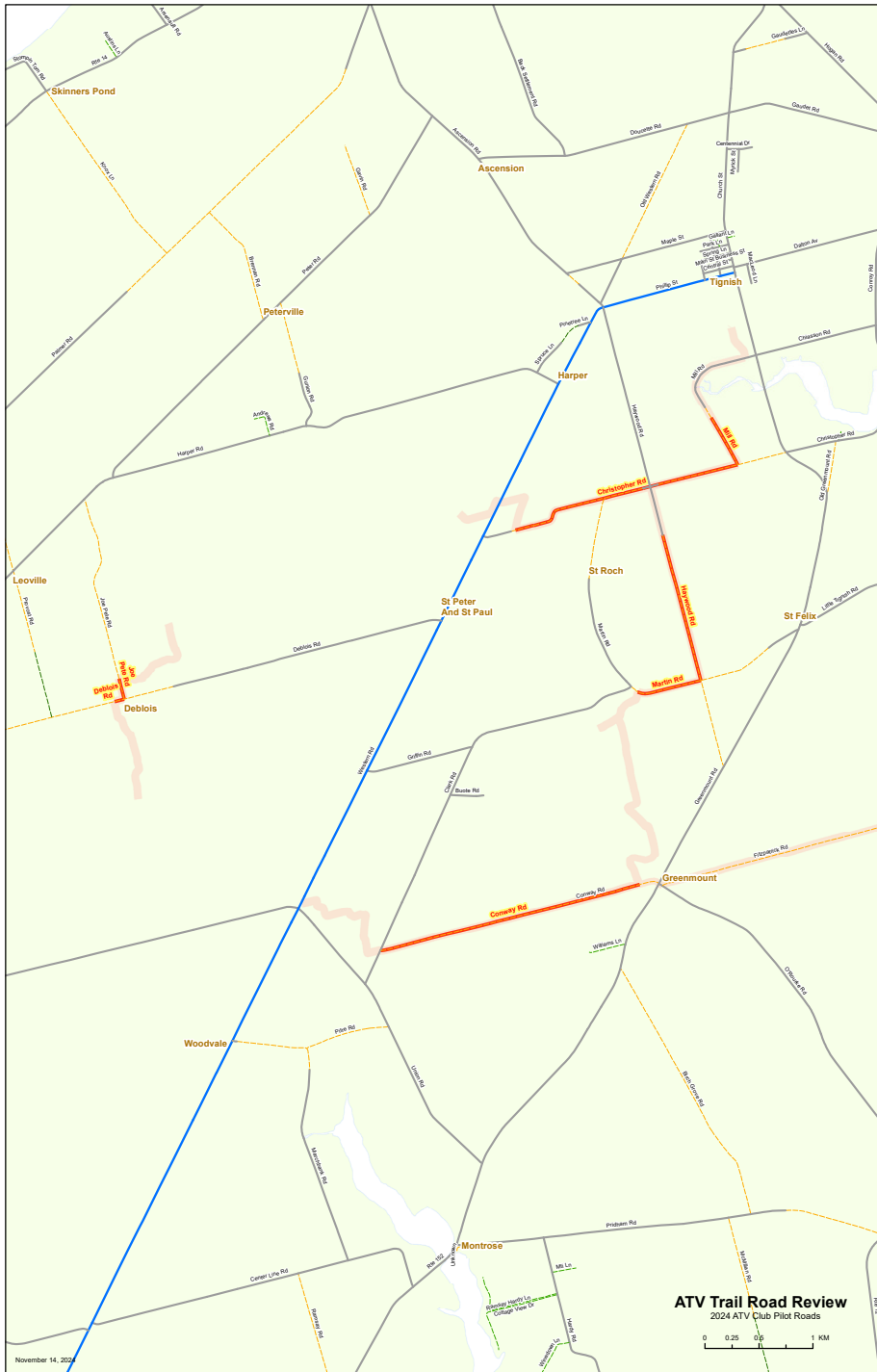

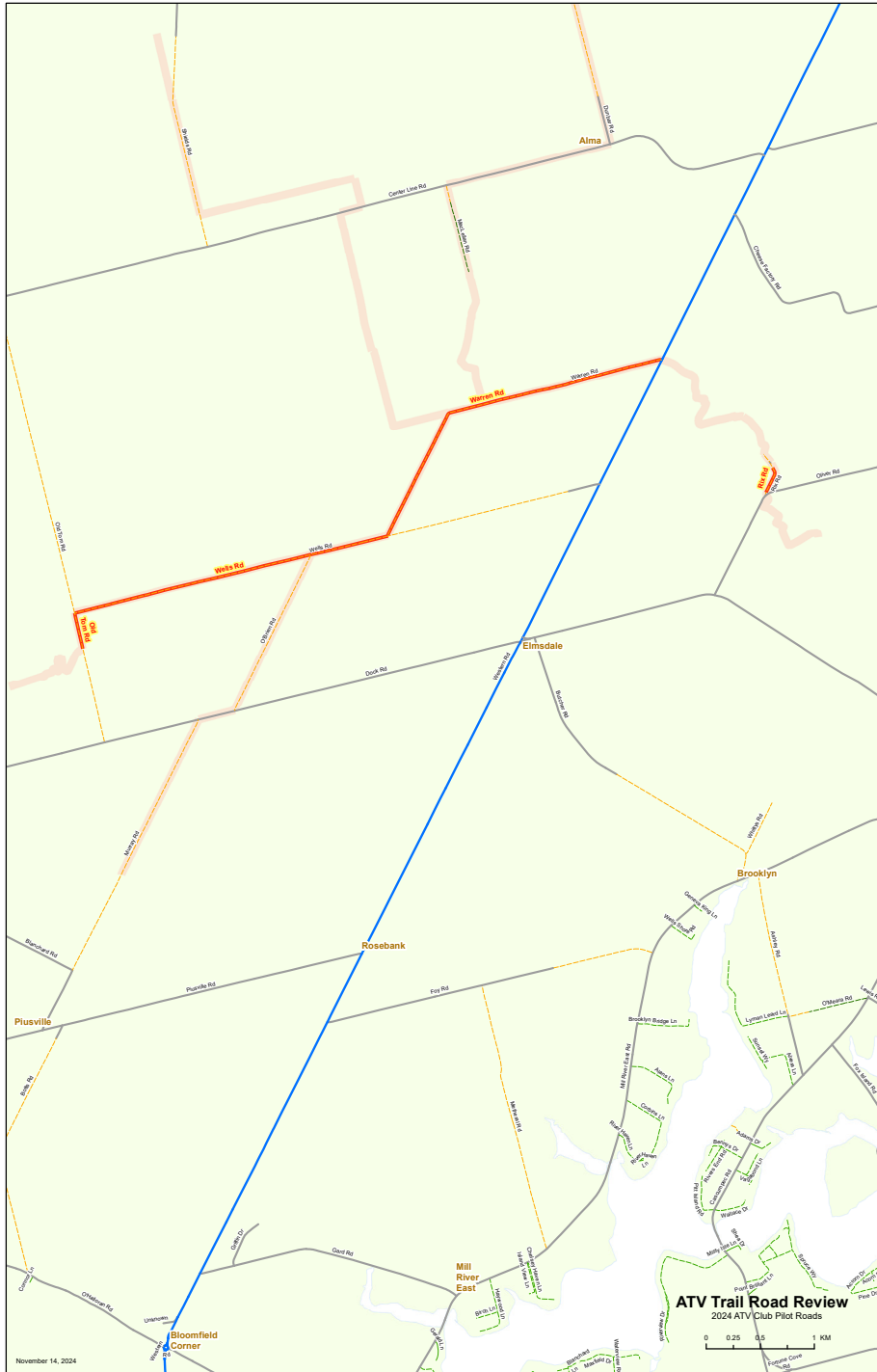

ROADS ACT

**HIGHWAY ACCESS REGULATIONS
AMENDMENT**

(Approved by His Honour the Lieutenant Governor in Council dated November 26, 2024.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. **Schedule C-1 to the *Roads Act* Highway Access Regulations (EC580/95) is amended by the revocation of subsection 1(286).**
2. **Schedule C-4 to the regulations is amended by the addition of the following after subsection (1):**

(1.1) **Mill Road RN 40284** The paved portion of Mill Road commencing at the intersection of Route 153 in the Town of Tignish to the intersection of RN 40081 in the Rural Municipality of St. Felix.

3. **Schedule D-1 to the regulations is amended**
 - (a) **by the revocation of subsection 1(70); and**
 - (b) **by the addition of the following after subsection 1(389):**

(389.1) **Mill Road RN 40284:** The unpaved portion of Mill Road commencing at the intersection of Route 153 in the Town of Tignish to the intersection of RN 40081 in the Rural Municipality of St. Felix.

4. **These regulations come into force on December 7, 2024.**

EXPLANATORY NOTES

SECTION 1 amends Schedule C-1, Local (Class 1) Highways, to the *Roads Act* Highway Access Regulations, by revoking subsection 1(286), which refers to the 0.9 km portion of Mill Road commencing at the intersection of Route 153 in the Community of Tignish.

SECTION 2 amends Schedule C-4, Local (Class 4) Highways, to the regulations, by adding a new subsection 1(1.1), which refers to the paved portion of Mill Road commencing at the intersection of Route 153 in the Town of Tignish and continuing to intersection of RN 40081 in the Rural Municipality of St. Felix.

SECTION 3 amends Schedule D-1, Seasonal Highways, to the regulations, by the revocation of subsection 1(70), which refers to the 0.6 km portion of the Arsenault Dam Road commencing 0.9 km from the intersection of Route 153 and continuing to the intersection of RI 11067, and the addition of subsection 1(389.1), which refers to unpaved portion of Mill Road commencing at the intersection of Route 153 and continuing to the intersection of RN 40081.

SECTION 4 provides for the commencement of the regulations.
