HIGHWAY TRAFFIC ACT

(Approved by Her Honour the Lieutenant Governor in Council dated December 12, 2019.)

Pursuant to sections 31, 65 and 312 of the *Highway Traffic Act* R.S.P.E.I. 1988, Cap. H-5, Council made the following regulations:

8. These regulations come into force on January 1, 2020.

EXPLANATORY NOTES

SECTION 1 amends the amount of the annual registration fee payable for a private passenger vehicle, taxicab or truck with a gross weight of less than 4,100 kg for which a fee is not otherwise provided under the regulations.

SECTION 2 revokes and replaces Table 1 in section 4 of the regulations in respect of changes to the annual registration fees for miscellaneous vehicles.

SECTION 3 revokes and replaces Table 2 in subsection 5(1) of the regulations in respect of changes to the annual registration fee for a vehicle owned by a municipality or a provincial Crown Corporation or commission.

SECTION 4 amends Table 3.1 in subsection 6.1(3) of the regulations in respect of changes to the annual registration fee and the non-expiring registration fee for a straight or tandem farm truck.

SECTION 5 revokes and replaces Table 4 in subsection 7(4) of the regulations in respect of changes to the annual registration fees by gross weight of trucks, including truck-tractors, and public passenger buses.

SECTION 6 revokes and replaces section 8 of the regulations to provide that the fee for a driver's license issued for a five-year period is \$116.

SECTION 7 amends Table 5 in section 9 of the regulations to specify the fees, where applicable, for photographic identification issued by the Registrar under subsection 6.1(1) of the *Highway Traffic Act*.

SECTION 8 provides for the commencement of the regulations.
