PRICE DETERMINATION ORDER

Application 1. This Order provides for the establishment of the prices for each kilogram of butterfat, protein and other solids contained in milk used in the classes described in the Board's Classification of Milk Order and adjustments to producer payments.

Definitions 2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:

(a) "Class 1 Milk" means the amount of litres of milk that is equal to the volume of sales in litres by a processor or distributor of Class 1 products processed by pasteurization, ultra high temperature treatment or sterilization.

(b) "Class 1 Milk Product" means standard milk, partly skim milk, skim milk, blend, cream, table cream, whipping cream, chocolate partly skim milk and flavoured milk.

(c) "CMSMC" shall mean the Canadian Milk Supply Management Committee.

(d) "P5 Target Price" shall mean the prices established for components utilized in each milk class by the five provinces, party to the Agreement on the Eastern Canadian Milk Pooling, that are used as references for all price determinations within the pool.

Component Prices and Billing Factors 3. The prices to be paid to Dairy Farmers of Prince Edward Island by processors for each kilogram of butterfat, protein and other solids contained in milk marketed and the standard billing factors, in kilograms per hectolitre of milk, for components used in the manufacture of Class 1 Milk products shall be as follows:

4. Class 1(c) is established to provide price discounts for milk components used in new fluid milk products. Class 4(c) is established to provide price discounts for components used in new industrial milk products.

Any new products introduced to the market shall be designated to a regular milk class and, if approved, shall be eligible for class 1(c) or 4(c) pricing for a maximum of three years. The discounts granted for approved products shall be based on the P5 target prices for the regular dairy product class to which the product has been designated, and shall be applied to the volume of components utilized in manufacturing the approved product.

Discounts to be applied to the butterfat, protein and other solids utilized in products approved for class 1(c) and 4(c) pricing are as follows:

- (a) 25% for the first year following the product's introduction;
- (b) 15% for the second year following the product's introduction; and
- (c) 10% for the third year following the product's introduction.

Revocation 5. DFPEI Order 2016-09 effective the 1st day of November 2016 is hereby revoked.

Commencement 6. This Order comes into force on the 1st day of February 2017.

Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

CREDIT TRANSFER ORDER

Application 1. This order establishes a system for the transfer of production credits between quota holders that are allotted quota by DFPEI.

Definitions 2(1) In this order

- (a) “credit” means an unused unit of milk production, equal to 1 Kg of butterfat quota, that is created when daily quota is not filled to its maximum potential, including any flexibility granted by DFPEI to manage milk production, as permitted by the quota credit system.
- (b) “credit purchaser” means a producer who has obtained credits from other producers;
- (c) “credit transfer” is the assignment of one or more credits from one producer to another, which may be for a fee.
- (d) “credit transfer exchange” means an exchange established, controlled and operated by DFPEI for the transfer of credits between producers;
- (e) “credit vendor” means a producer who has transferred credits to other producers;
- (f) “DFPEI” means Dairy Farmers of Prince Edward Island
- (g) “milk” includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;
- (h) “producer” means a person, partnership or company that produces milk for sale;
- (i) “quota” means a dairy producer’s share of the market for milk as fixed and allotted by DFPEI;
- (j) “quota credit system” a mechanism established by DFPEI that allows milk producers to over ship up to a maximum of ten (10) times their daily quota on a cumulative basis, referred to as over quota production credits, or to under ship up to a maximum of thirty (30) times their daily quota on a cumulative basis, referred to as under quota production credits.

2(2) The words herein shall have the meanings as found in the *Natural Products Marketing Act*, the Dairy Farmers of Prince Edward Island Regulations under that Act.

Credit Transfer 3. Any credit transfer conducted between producers shall be transacted under the conditions established by this order.

Credit Transfer Quantities and Limits 4. Credits may be transferred in quantities expressed in kilograms of butterfat rounded to zero decimal places. The quantity of credits an individual producer may transfer at any one time shall be limited to an amount specified from time to time by a DFPEI Order. The specified maximum number of credits a producer may purchase or sell each month, effective 1 February 2017, shall be equal to not more than twenty-five percent (25%) of the production permitted by the producer's quota for the calendar month in which the transfer occurs. For the purpose of this calculation, the production permitted for the calendar month the credit transfer occurs is calculated by multiplying the producer's current daily quota allocation by the number of days in the calendar month.

Credit Transfer Exchange 5. DFPEI shall operate a credit transfer exchange for facilitation of credit transfers between producers.

Direct Producer to Producer Transfers 6. A producer is permitted to transfer credits directly to or from another producer, without participation in the credit transfer exchange.

Producer to Producer Contracts 7. All producer-to-producer credit transfers shall be registered with DFPEI using a Credit Transfer Contract Form provided by DFPEI. Contracts must be delivered to the Board office by 4 PM on the twenty-fifth day of the month of transfer. Where the twenty-fifth of a month falls on a weekend or a statutory holiday, the board shall accept producer-to-producer contracts until 4 PM on the next business day.

Contract Registration Fee 8. A registration fee of \$20.00 shall be paid to DFPEI to administer all direct producer-to-producer credit transfer contracts.

Payment for Transfers 9. All payments for credit purchases, regardless whether the transfer was made through credit transfer exchange or by a producer-to-producer credit transfer agreement, shall be payable to Dairy Farmers of Prince Edward Island and payments shall be disbursed to credit vendors by DFPEI. Payments must be received at the DFPEI office by 4PM on the second business day following the deadline for contract submission. Failure to deliver the required payment as ordered in this section shall result in cancellation of the contract.

Default of Payment 10. In the event of default of a payment for credit transfer, DFPEI shall require the credit purchaser to remit guaranteed payment, by bank draft or comparable payment method, within 2 business days of notice to the credit purchaser that their payment has been dishonoured. The guaranteed payment remitted shall be sufficient to pay the cost of the purchase, contract registration fee and any service charges related to the default that are levied by third parties.

Right of Offset 11. In the event of a default of payment for a transfer for which a producer is unable to provide guaranteed payment within 2 business days, as outlined in section 10, DFPEI shall retain the right to offset the indebtedness created by the default of payment against future revenues for milk sales, credit sales or quota sales, and shall withhold the required funds from future payments to the credit purchaser for settlement of the account.

Assignment prohibited 12. Credits may not be assigned to lenders. A producer's obligation created by an assignment of quota to a lender is not relieved by any credit transfer transaction.

Transition 13. Quota leases for the Month of February 2017 created under the authority of orders DFPEI 2007-02, Quota Leasing Order, and DFPEI 2005-06, Quota Leasing Exchange Order, for the month of February 2017 shall be executed as agreed.

Revocation 14. Dairy Farmers of Prince Edward Island Orders DFPEI 2007-02, dated the 29th day of May 2007 and DFPEI 2005-06 dated 26 May 2005 are hereby revoked.

Commencement 15. This Order comes into force on the first day of February 2017.

Application 1. This order establishes the methodology for applying the pricing structures approved in the harmonized billing mechanism approved for implementation by the Canadian Milk Supply Management Committee “(CMSMC”).

Definitions 2. The words herein shall have the meanings as found in the *Natural Products Marketing Act*, the Dairy Farmers of Prince Edward Island Regulations under that Act unless differentiated herein and as hereinafter defined:

(a) “Canadian Milk Supply Management Committee” or “CMSMC” means the federal-provincial organization created under the authority of the National Milk Marketing Plan to provide administrative governance to the operation of the plan;

(b) “Class 1A” means a category of milk products defined under the DFPEI Milk Classification Order;

(c) “Class 3” means a category of milk products defined under the DFPEI Milk Classification Order that includes all sub classes from 3A to 3D;

(d) “Class 7” means a category of milk products defined under the DFPEI Milk Classification Order;

(e) “DFPEI” means Dairy Farmers of Prince Edward Island;

(f) “harmonized billing mechanism”, or “HBM”, means a system created to allow competitive pricing of milk components or ingredients that may be used in the manufacture of Canadian dairy products;

(g) "milk" includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;

(h) "milk buyer" means a processor that purchases milk directly from DFPEI;

(i) "milk components" means the three identified types of solid material derived and marketed from milk, referred to as butterfat, protein and other solids;

(j) "milk utilization audit" is the verification process that confirms processors' milk utilizations have been recorded accurately and in compliance with Milk Utilization Standards;

(k) "milk product" means any product derived in whole or in part from milk;

(l) "Milk Utilization Standards" is a document created by the Canadian Dairy Commission that records all established requirements for recording milk utilizations in the Canadian Dairy industry;

(m) "National Milk Marketing Plan" is a federal-provincial agreement created for the governance of the dairy industry;

(n) "non-milk buyer" means a processor that does not purchase milk directly from DFPEI;

(o) "processing" means heating, pasteurizing, sterilizing, evaporating, drying, churning with other substances by any process, or otherwise treating milk in the manufacture or preparation of milk products and for clarity, includes any reworking, reprocessing or repackaging of previously manufactured dairy products.; and

(p) "processor" means a person or partnership performing any processing of milk.

Component	
Billing	3. All milk components sold to processors shall be billed in accordance with the harmonized billing mechanism established under this order.
Billing at Regular	
Product Class	4. Unless otherwise indicated in this order, all milk components used in the manufacture of dairy products shall be billed at regular class prices as determined by DFPEI from time to time.

Billing Ratios	5. Harmonized billing ratios, or "HBR", are established nationally to permit components and ingredients derived from milk components to be priced competitively to processors in the portions permitted for ingredients under Canadian law. Billing ratios will be determined by the CMSMC from time to time and shall be recorded in the Milk Utilization Reporting Manual established under this order.
Application of	
Class 7 Pricing	6. Class 7 Prices apply to: <ol style="list-style-type: none">(a) milk components utilized in products classified in class 7 that are sold as finished products;(b) milk components utilized in products sold as ingredients for use in the manufacture of non-dairy food products;(c) milk components utilized in the manufacture of animal feed; and(d) milk components utilized as ingredients in dairy products classified in other classes

by the Canadian Harmonized Milk Classification System, on a skim milk equivalent basis and within the limits imposed by HBR.

7. When an ingredient ratio is created for application to any milk or milk products not classified in Class 7, then the ratio will be applied to the milk components identified in the ratio and the Class 7 component prices shall be applied to the portion of those milk components identified as eligible for ingredient pricing.

8. Processors must declare all milk components from all sources used in any milk product to be eligible for Class 7 Pricing for that product. However, for purposes of calculating protein utilization in Class 3 and all Class 3 sub-classes, proteins sourced from whey or whey by-product sources are not included in the eligible milk components calculation.

Ingredient Sellers
Responsibility

9. Processors that sell Class 7 ingredients are responsible to ensure that any such product is eligible for that classification. Purchasers of Class 7 products shall confirm that they will make records available and permit audit to verify that eligibility. If eligibility can not be demonstrated through the purchaser's records or audit, then the seller shall be subject to assessment of a billing adjustment to revise the product price to Class 1A prices.

National
Centralized
Registry System

10. A National Centralized Registry System (NCRS) will be established by the Canadian Dairy Commission for milk buyers and non-milk buyers. Upon completion, a valid registration number from this system will be required to conduct Class 7 milk component transactions. During transition to the NCRS, records must be kept in accordance with requirements specified by the CMSMC.

Revenue calculated

11. If a processor uses more Class 7 ingredients than specified by the HBR for any milk product, that processor shall be subject to a price adjustment from Class 7 to the higher class milk component prices on the volume of Class 7 milk components that exceed the Class 7 utilization permitted in the HBR.

12. All milk utilizations reported by milk buyers and non-milk buyers are subject to verification by audit. Utilization audits shall be conducted in accordance with direction from CMSMC and shall meet all guidance established in the dairy industry's Milk Utilization Standards.

13. DFPEI, as a member of the CMSMC, is party to all decisions of the CMSMC. Consequently, decisions of the CMSMC regarding the HBM and HBR shall be considered amendments to policies of DFPEI recorded in the Milk Utilization Reporting Manual.

14. Details and clarifications of reporting procedures established by the CMSMC will be aggregated in a Milk Utilization Reporting Manual prepared by DFPEI. This manual will contain the HBR, and detailed interpretations of the HBM, together with expanded instructions and rules for milk utilization reporting. This manual will be updated from time to time by DFPEI as interpretations and operating procedures related to utilization reporting and the HBM evolve.

Commencement

15. This Order comes into force on the first day of February 2017.

Milk Utilization Audit Order

Application	1. This order establishes the policy and authorities to conduct milk utilization audits.
Definitions	2. The words herein shall have the meanings as found in the <i>Natural Products Marketing Act</i> , the Dairy Farmers of Prince Edward Island Regulations under that Act unless differentiated herein and as hereinafter defined: <ul style="list-style-type: none">(a) “Canadian Milk Supply Management Committee” or “CMSMC” means the federal-provincial organization created under the authority of the National Milk Marketing Plan to provide administrative governance to the operation of the plan;(b) “DFPEI” means Dairy Farmers of Prince Edward Island(c) “milk” includes whole milk and such products of milk that are supplied, processed, distributed or sold in any form;(d) “milk buyer” means a processor that purchases milk directly from DFPEI;(e) “milk components” means the three identified types of solid material derived and marketed from milk, referred to as butterfat, protein and other solids.(f) “milk utilization audit” is the verification process that confirms processors’ milk utilizations have been recorded accurately and in compliance with Milk Utilization Standards;(g) “Milk Utilization Standards” is a document that records all established requirements for recording milk utilizations in the Canadian Dairy industry;(h) “non-milk buyer” means a processor that does not purchase milk directly from DFPEI;(i) “processing” means heating, pasteurizing, sterilizing, evaporating, drying, churning with other substances by any process, or otherwise treating milk in the manufacture or preparation of milk products and for clarity, includes any reworking, reprocessing or repackaging of previously manufactured dairy products.; and(j) “processor” means a person or partnership performing any processing of milk.
Requirement to Audit	3. All milk components sold to processors are subject to: classification as established under the DFPEI Milk Classification Order; component prices as established under the DFPEI Price Determination Order; and pricing policy applications as established under the DFPEI Price Application Order. In order to ensure the policies in these orders are applied correctly, all sales are subject to confirmation by milk utilization audit to confirm

their accuracy. The requirement to audit is extended to milk buyers, non-milk buyers and further processors purchasing milk components or ingredients for use in milk products and other food products. Audits shall be conducted in accordance with Generally Accepted Auditing Standards.

Engagement of an Auditor

4. DFPEI shall engage an auditor to perform milk utilization audits on its behalf. The selection of milk utilization auditor shall include an assessment of a perspective auditor's understanding of the industry. Perspective auditors must demonstrate comprehension of the complexities of the provincial and national milk marketing systems and the Milk Utilization Standards.

Efficiency Encouraged

5. Wherever possible, the auditor shall utilize proven auditing techniques that improve efficiency, such as risk base auditing, provided those techniques ensure a high degree of assurance in the accuracy of milk utilization reporting.

Use of Technology Encouraged

6. Wherever possible, the auditor shall utilize technology, such as milk utilization recording software, to improve efficiency of the audit process and reduce cost, provided the use of technology does not compromise the accuracy of the audit.

Cost of Audits

7. Milk utilization audits shall be conducted under contract at an agreed price between DFPEI and the selected auditor. DFPEI shall consult processors when negotiating audit contracts. The cost of each audit will be evenly divided between DFPEI and the processor that is audited.

Authority of Auditor

8. The auditor and any employees of the auditor who conduct milk utilization audits (hereinafter referred to as "auditors") are acting on behalf of DFPEI. Therefore, auditors shall exercise the authority to inspect the books and premises of persons involved in the production or marketing of milk and milk products that is granted to DFPEI under the Act.

Audit Adjustments

9. Where any person engaged in the production or marketing of milk and milk products has been found to have incorrectly recorded transactions, be it with regard to classification, price, price application, volume or any other material factor, the auditor may issue an audit adjustment that directs correction of the error. Audit adjustments must be settled within thirty (30) days of the date on which they are issued.

Suspected Fraudulent Activity

10. In any instance where auditors suspect fraudulent activities have occurred, the auditors shall report the suspect transactions to DFPEI for further investigation and possible corrective action.

Transactions between multiple entities

11. Any transaction conducted between multiple entities subject to the authority of DFPEI shall be subject to audit from the sale of milk from the farm to delivery to an entity not subject to this regulation. This includes, but is not limited to, transactions between:
 - (a) two or more plants owned by the same processor;
 - (b) two or more processors;
 - (c) processors and distributors; and
 - (d) processors or distributors and further processors engaged in the manufacture of food products other than dairy products.

Interprovincial Transactions

12. In any instance where milk or milk products are reported to be delivered to a processor or

further processor in another province, the auditors may communicate to, and coordinate audit activities with, the auditors for that province to ensure the final disposition of the product is verified and all related transactions comply with DFPEI Orders.

International
Transactions

13. In any instance where milk or milk products are reported to be delivered to an international buyer, the auditors may request confirmation of transaction details as required in the Milk Utilization Standards, to confirm the disposition of the product and eligibility for any related component pricing.

Commencement 14. This Order comes into force on the first day of February 2017.

Under the *Natural Products Marketing Act*, R.S.P.E.I. 1988, Cap. N-3, and the Dairy Farmers of Prince Edward Island Regulations thereunder, Dairy Farmers of Prince Edward Island makes the following Order:

MILK CLASSIFICATION ORDER

Application 1. This Order establishes the Classes of Milk in Prince Edward Island.

Definitions 2. The words herein shall have the meanings as found in the Prince Edward Island *Natural Products Marketing Act* and the Dairy Farmers of Prince Edward Island Regulations unless differentiated herein and as hereinafter defined:

- (a) “CMSMC” shall mean the Canadian Milk Supply Management Committee;
- (b) “cheddar type cheese” - a cheese of descriptive nomenclature will be recognized as cheddar-type cheese for the purpose of classification if it is a firm or semi-soft, unripened, unwashed curd cheese, with a minimum milk fat content of 25% and a maximum moisture content of 45%;
- (c) “losses” - unless otherwise specified refers to explained losses such as dumped milk or fluid returns;
- (d) “milk protein concentrate” or “MPC” is a dairy protein product with a protein content greater than 42% on a dry matter basis; and
- (e) “milk protein isolate” or “MPI” is not formally defined but is used to describe MPC at very high protein content, usually more than 70%.

3. The following classifications of milk are established:

- (b) Class 1(b) milk;
- (c) Class 1(b)ii milk;
- (d) Class 1(c) milk;
- (e) Class 1(d) milk;
- (f) Class 2(a) milk;

- (h) Class 3(a) milk;
- (i) Class 3(b) milk;
- (j) Class 3(c)1 milk;
- (k) Class 3(c)2 milk;
- (l) Class 3(d) milk;
- (m) Class 4(a) milk;
- (n) Class 4(a)1 milk;
- (o) Class 4(b) milk;
- (p) Class 4(c) milk;
- (q) Class 4(d) milk;
- (r) Class 4(m) milk;
- (s) Class 5(a) milk;
- (t) Class 5(b) milk;
- (u) Class 5(c) milk;
- (v) Class 5(d) milk; and
- (w) Class (7)

Harmonized Milk

Classification System

4. The following classes are established in accordance with the Harmonized Milk Classification System adopted by the CMSMC, 22 April 2010 and amended from time to time. This system classifies processor utilization of milk, partially skimmed, skim milk, creams, concentrated milk or a mix for products listed in the following classes.

Class 1(a) Milk

5. Class 1(a) - Milk and milk beverages, partly skimmed or skimmed, whether or not treated for lactose intolerance, whether flavoured or not, with or without vitamins or minerals added, for retail and food service, also including:

- (a) egg nog;
- (b) cordials;
- (c) cultured milk; and
- (d) concentrated milk to be reconstituted as fluid milk.

Class 1(b) Milk

6. Class 1(b) - All types of cream with a butterfat content not less than 5% for retail and food service.

Class 1(b)ii Milk

7. Class 1(b)ii - Fresh cream with a butterfat content of 32% and higher used to make fresh baked goods, which are not eligible for a Class 5 permit. Any utilization in this class requires a Class 1(b)ii permit issued by the Canadian Dairy Commission.

Class 1(c) Milk

8. Class 1(c) - New class 1(a) and 1(b) fluid products for Retail and Food Service that are approved by Dairy Farmers of Prince Edward Island during an introductory period.

Class 1(d) Milk

9. Class 1(d) - Class 1(a) and 1(b) fluid products marketed outside the ten signatory provinces but within the boundaries of Canada, (e.g.: Yukon, NWT, Nunavut and cruise ships).

Class 2(a) Milk 10. Class 2(a) - All types of yogurts including yogurt beverages, Kefir and Lassi, excluding frozen yogurts.

Class 2(b) Milk 11. Class 2(b):

- (a) all types of ice cream, ice cream mix, whether frozen or not;
- (b) other frozen dairy products including frozen yogurts;
- (c) all types of sour cream;
- (d) all types of milk shake mixes; and
- (e) the following products: fudge, puddings, soup mixes and Indian sweets.

Class 3(a) Milk 12. Class 3(a) - All cheeses other than those identified in Class 3(b), Class 3(c)1, Class 3(c)2 and Class 3(d).

Class 3(b) Milk 13. Class 3(b) - All types of cheddar cheese, stirred curd, cream cheese, creamy cheese bases (cheese mixes), cheddar and cheddar-type cheeses sold fresh. Any product not referred to in Class 3(a), elsewhere in 3(b), 3(c) or 3(d) made by coagulating milk, coagulating milk products or coagulating both milk and milk products with the aid of bacteria to form a curd excluding rennet casein curd used in the manufacturing of non-standard final products in the processed cheese category.

Class 3(c)1 Milk 14. Class 3(c)1 - Asiago, Canadian Style Munster (Muenster), Feta, Gouda, Havarti, Parmesan, Swiss.

Class 3(c)2 Milk 15. Class 3(c)2 - All types of Mozzarella except when declared in Class 3(d) (including but not limited to part skim Mozzarella, part skim Pizza Mozzarella, Pizza Mozzarella), Brick, Colby, Farmer, Jack, Monterey Jack.

Class 3(d) Milk 16. Class 3(d) - Standardized mozzarella cheeses to be used strictly on fresh pizzas by establishments registered with the CDC under terms and conditions approved by the CMSMC.

Class 4(a) Milk 17. Class 4(a):

- (a) all types of butter and butter oil;
- (b) all types of powders other than those identified in Class 7;
- (c) all types of powder with over 4% butterfat content and packaged for retail;
- (d) liquid MPC and MPI made from whole or partly skimmed milk (greater than 4% BF), in any concentration, derived by any process;
- (e) concentrated milk, whether sweetened or not, not for retail; and
- (f) all other products not elsewhere stated.

Class 4(a)1 Milk 18. Class 4(a)1 - Milk components for the manufacture of rennet casein (dry or curd), MPC (dry or liquid) or skim milk (dry or liquid) to be used in the manufacture of non-standardized final products in the processed cheese category.

Class 4(b) Milk 19. Class 4(b) - Concentrated milk for retail sale whether sweetened or not.

Class 4(c) Milk 20. Class 4(c) - New industrial products as approved by Dairy Farmers of Prince Edward Island during an introductory period.

Class 4(d) Milk 21. Class 4(d) - Inventories and losses.

Class 4(m) Milk 22. Class 4(m) - Milk components for marginal markets as established from time to time by the CMSMC.

Special Milk Classes 23. Special Milk Classes reflect the wording of the "Comprehensive Agreement on Pooling of Milk Revenues". All milk components necessary for the production of products containing dairy ingredients can be accessed through subclasses of Class 5 (Special Milk Classes) and/or exported dairy products (Class 5(d) only).

- (a) Class 5(a) - Cheese used as ingredients for further processing for domestic and export markets.
- (b) Class 5(b) - All other dairy products used as ingredients for further processing for the domestic and export markets.
- (c) Class 5(c) - Dairy products used as ingredients for the confectionery sector destined for domestic and export markets.
- (d) Class 5(d) - Planned exports and other exports approved by the CMSMC, the total of which shall not exceed Canada's WTO commitments.

Ingredients Class 24. (1) Class 7 - Eligible components, products and ingredients:

- (a) skim milk components in liquid and dry form, in any concentration, derived by any process, including MPC and MPI⁽¹⁾;
- (b) skim-milk powder;
- (c) whole milk powder⁽²⁾;
- (d) edible casein and edible caseinate powders⁽³⁾;
- (e) yogurt powders, sour cream powders, and partly-skimmed milk powder and blended milk powders with a maximum fat content of 4%; and
- (f) rennet casein (dry or curd) used in the manufacture of non-standardized final products in the processed cheese category⁽⁴⁾.

(2) Milk used to make the components, products and ingredients within Class 7, that are subsequently used to process a product in another class is deemed to come within that other class for milk pricing and billing purposes, as defined in the Harmonized Billing Mechanism.

Notes

- (1) Eligibility of liquid is subject to specific rules described in the administrative measures of the Harmonized Billing Mechanism.
- (2) Subject to rules that have yet to be established.
- (3) Including Casein, sodium caseinate, calcium caseinate.
- (4) As per the procedure defined in the National Audit Standards

Revocation 25. Dairy Farmers of Prince Edward Island Board Order DFPEI 2016-08 effective the 1st day of November 2016 is hereby revoked.

Commencement 26. This Order comes into force on the 1st day of February 2017.
