

### **Am I eligible for funding?**

If you are a professional artist who is a resident of PEI, and have lived here for a minimum of 6 months before the application date, you are eligible to apply for funding.

### **Who is considered a professional artist?**

You will need to establish your professional status through your artist CV. Your CV should include all your training, paid professional experience in your discipline, awards, prizes, exhibitions, tours, recorded albums, films, or any other professional experience that relates to your arts experience.

### **Is this funding program for me?**

If you are a professional artist, who is a resident of PEI, working in the following disciplines, yes: crafts; dance; interdisciplinary arts; film and media arts; music; theatre; visual arts; and writing and publishing.

### **What kind of projects do you fund?**

Juries tend to award funding to projects that include in their application, the following: well thought out and clearly described project idea with a strong artistic vision, a list of project activities and timeline, a budget that makes sense for the activities listed, and good quality support material. Juries want to understand what your project will accomplish for you as an artist and what the impact the project will have.

### **Can I start my application, save it and finish it later?**

No. We highly recommend you create your full application in a word document that you can copy/paste your information into the form because once you start the application you will have to completely finish it in one session.

### **How many times can I apply?**

You can apply for funding each round (Fall and Spring) but if you are a successful funding recipient you will need to complete your project and submit a final report before you are able to apply again.

### **When will I know if I received funding?**

Best efforts are made to make sure that all applicants are notified within 4 weeks of the funding deadline.

### **I didn't receive funding, can I get some feedback?**

Yes, you may request feedback from the Creative Industries Development Officer to receive high-level feedback on your grant application in order to help you prepare to apply again in the future.



**I received funding, when will I receive payment?**

Once you are notified of your successful application, you will be contacted to sign a contract and arrange for payment.

**When is my final report due?**

Your final report is due when you finish your project (as outlined in your application). If you need to adjust your end date, please contact our [Cultural Development Officer](#) at Innovation PEI.

**Do I need to include your logo or acknowledge the funding support?**

Yes please. When your grant funding is confirmed we will send you a copy of our logo, or you can [download it here](#). Please include the logo and the following statement whenever it is possible and appropriate: Funding for this project is (partially) provided by Innovation PEI through the PEI Culture Action Plan.

**Can I apply to more than one program at the same time in the same funding round?**

Yes, you can apply to all three streams (Creation, Dissemination, Professional Development), but only one application per stream is allowed.
